Call **Bexar County Animal Control** at **210-207-6650** to have loose Dogs or Cats picked up. They will provide a cage to catch stray cats, then they will pick up. There is a leash law in Bexar County for both Dogs and Cats. They do have to be registered and Licensed. There have been many calls about dogs running loose. **Remember Bexar County has a Leash Law.**

If any one sees someone with the intent to paint (GRAFFITI) or disfigure the MR Marquee or other property, please call: **Bexar County Sherriff's Department@ 210-335-6000**. This is criminal activity and will be reported for investigation and prosecution.

You are the eyes and ears of your community, if you see anything Suspicious activity call: **Bexar County Sherriff's Department@ 210-335-6000** To report it while it is happening, you do not have to give your name. Bexar County does have a curfew of 11:00 pm for anyone under 17 and under that is out without adult supervision.
