# Wet, Freezing Weather Slows Progress

It may not seem so at first glance, but much progress has been made cleaning up the mudslide in front of the clubhouse. Unfortunately due to the wet, freezing weather we've been experiencing lately, work has been temporarily halted.

Work will resume as soon as the weather clears and the ground dries out. All of the dirt currently piled in the roadway will be compacted back into the hillside and held in place with rock and bio-grid. The final step will be spraying hydro-grass, which will further help to stabilize the hill.

Thanks to all residents for their patience in this matter.

The second slide (aka "210 slide") will be outfitted with a drain for now to prevent further sliding. This slide will be addressed sometime later this year or next.

Improvements to the creek bed are also part of Belle Forest's long term plan.

# **STARTING MARCH 1**

### **Rules, Regulations Enforcement**

Starting on March 1, 2011 the following will recommence:

Porch & Patio Inspections - if your porch, patio does not pass inspection you will receive a letter requesting that you remove any and all objects not permitted as stated in the BF bylaws. You can and will be fined for non-compliance.

Cars Tagged & Towed - any cars parked on the property that do not have current registration or are inoperable will be tagged and towed.

## LATE FEES

### Late Fee Forgiveness to End

As of March 1, 2011 any community fees received after the due date will incur a \$50 late fee. There will be no more forgiveness of these fees, regardless of reason for late payment.

# Long, Cold Winter Challenges BF Plumbing

When the temperature drops below 32°:

- Drip faucets to keep water pumping through the pipes.
- Open cabinet and dishwasher doors.
   This will allow heat from the house to reach pipes and keep them warm.

### If you have a burst pipe:

- Turn off the water to your unit via the main, outside valve.
- Call a plumber!
- Notify your neighbors (most main valves shut off two or more units, not just yours).
- Notify the management company.
