### WHAT'S IN THE WORKS

#### Short & Long Term Plans to Preserve, Protect & Enhance Belle Forest

**BUILDING REFURBISHMENTS:** The bidding process has begun for building refurbishments. Synergy has created and the board has approved a comprehensive scope of work for repairing and restoring our buildings. This scope includes stucco repair, rotted wood replacement, painting and more. The goal is to begin work in July.

MULCH, TREES, ETC.: Mulch dispersal has been completed for all who requested it. Please remember that if you did not request mulch or garden maintenance that both are your responsibility. Please use mulch that matches what has already been put down - brown shredded pine bark.

The landscaper has been contracted to trim trees on the property. Many of our beautiful trees hang quite low, so those trees will be trimmed in order to lift the canopy. This will also keep the trees healthy.

Gutters on buildings will be inspected periodically and cleaned out as necessary. If you see gutters that are full and therefore not moving water off the roof properly, please let Synergy know.

**POTHOLES:** The potholes at the 210 entrance have been cold patched as a short term repair.

**PLUMBING:** A major water leak was discovered and repaired, potentially saving us hundreds of dollars off the water bill. We will be pro-actively looking for more such leaks and repairing them.

MUD SLIDE - 210 ENTRANCE: An engineer has been contracted to analyze this big slide and produce several options for repair. Once this process is complete we will be better equipped to make decisions regarding repair. Thanks to everyone for their patience in this matter.

**POOL:** Several coping stones around the pool have been replaced, all the coping has been re-grouted, and the deck as been repaired in several spots.

## NEWD BELLEVUE AREA HISTORY COLUMN

#### BELLEVUE'S BROWN SCHOOL

The following memory of Bellevue is excerpted and edited by Bob Allen from the Pat Knapp Collection with permission.

Eleanor Brown's grandparents, John and Georgia Brown lived on a farm in Bellevue and their neighbor, the Sawyers, farmed close by. The Brown family donated land on Charlotte Pike for a school to be used only for African-American children living in Bellevue. Many of these folks lived in the Old Hickory and Charlotte area; the school was needed and welcomed.

For many years the school was filled with children, holding classes for grades one to eight. Most of that section of Charlotte was not yet developed, although a very old woman lived in a home next to the school, which is the present site of the VFW property.
