


Tucson Police Department...

TPD has been responding to concerns brought to the attention of the ENA and/or various departments of the City of Tucson.

Currently on the priority list is NO parking on the sidewalks. An effort is underway to warn or ticket those who are parked on the sidewalk or the area designated as a sidewalk. Sidewalk areas are reserved for pedestrian use only. A \$50-\$100 fine is issued to those who receive a ticket. Please help keep children off the streets and on the sidewalk.

Another issue TPD has responded to is the traffic congestion at Teton and 6th Avenue. Challenger Middle School buses pick up and drop off students along Teton, traffic at 6th Avenue, the fact that there is no distinction between the street and the sidewalk at the intersection, as well as parent/ student drop- off, create unsafe traffic and pedestrian conditions. Neighbors who live in this area have also reported high speed traffic at all hours and automobile accidents that damage the fences of their homes. TPD has filed a public hazard report and the City of Tucson Traffic Division will be conducting a study of the area.

Speeding is almost the number one complaint from neighbors. We are the home of the city's deadliest intersection. Please use the speed limit for safety.



DID YOU KNOW??

It is illegal to block the sidewalk or the side walk area? You can not park on a sidewalk, drive over a sidewalk, except for a driveway, pull up on a sidewalk to discharge passengers, let your bushes grow over the area, let your gate block the way or have any obstruction under penalty of law. Fines may be imposed up to \$1,000 per offense.

Unless you have a permit, you can hold a yard sale only once every 3 months?

It is illegal to dump unwanted items on vacant lots? This is not only a no-no, but is unsightly and a public nuisance. The City holds a brush and bulky pick-up twice a year, June & Dec.and the E.N.A. holds a clean-up at least once a year. Do your part to make our area a clean and safe neighborhood.

It is unlawful to have an abandoned vehicle for longer than 48 hours on your premises.?

It is unlawful to allow your barking dog to create a disturbance?

It is illegal to paint graffiti on someone else's walls or property

It is unlawful to damage or vandalize roadside plantings?, such as the new plantings on on our walking path.

The speed limit on our streets is 25 mph unless posted otherwise in a school zone.

Fines can and will be levied in all the above?

City of Tucson Regulations for Yard Sales

A homeowner or renter may have vard sales occurring no more than two times in a three-month period, three times in a six-month periodic and four times in a twelvemonth period. If the number of vard sales exceed these amounts the sales are a commercial activity and are not permitted on residential property. Yards sales are for selling excess personal goods, commercial goods cannot be sold at a vard sale.

A weekend vard sale starting on Friday evening and ending on Sunday evening is considered one vard sale.

In order to be in compliance with the City of Tucson Land Use Code, vard sales must meet the requirements listed above. Failure to comply with the Land Use Code could result in the issuance of a civil citation which carries a maximum fine of \$2500 for each violation.


Handbills (posters, signs, notices, etc.) may not be posted on public property, street right-of-ways, telephone or utility poles or on public buildings. The City may remove any handbill posted illegally and the costs of removal may be assessed against the persons who illegally posted the handbills.



B Elvira Neighborhood Association receives numerous grants that total over 1 million dollars. Elvira receives \$800,000 from the Back to Basics Program, \$150,000 from Pima County Reinvestment Program, and \$296,000 from the Governor's Division for Children and the Department of Justice. The City of Tucson makes a duel impact in the Elvira Community by providing dollars for both capital improvements and youth programs.
