NEW INFORMATION

<u>Dryer Vents</u>: There have been questions regarding dryer vents. We encourage everyone to clean their dryer vents from the wall to the dryer, as this is every owner's responsibility to do so on an annual basis. We have hired Holbrook Roofing to inspect and clean ventilation on all roof tops annually.



<u>Dog Waste</u>: This is meant to make very clear to all pet owners that any area outside of your unit is considered common area of the complex and not your personal property. Therefore, whenever letting your pet out, or walking them, you are <u>required</u> to immediately clean up their waste. Notices will be mailed for breaking violations of this Article VI, Section V, of the Rules & Regulations of West Grove Condominiums. A second occurrence will result in a fine of \$50.00,

A third occurrence will result in a fine of \$100.00,
Any occurrence thereafter, will result in a \$200.00 fines.
These fines, if not paid, will be deducted from your monthly Condo fees; resulting in late fees and possible liens on your property if not paid.



<u>Painting Schedule</u>: We will be scheduling, spring of 2012, the remainder of the buildings that have not yet been painted, starting with Bunte, Redman, Stromp, Boller, and Mahoney.

<u>All Exterior Doors</u>: All exterior doors, including garage doors, are home owners responsibility to maintain. Paint color code is required and can be purchased from Sherwin Williams on West Rd. in Trenton.

Roofs: Will be re-inspected in the spring to see if any necessary replacements are needed at this time.

<u>Parking:</u> Visitor parking is only on the cemented areas in the complex.

<u>Speed & Driving Regulations:</u> Please obey posted speeds of 10 miles per hr, and abide the one way driving off of West Grove Circle.

<u>Pets:</u> Pets are a privilege and should always be on a leash and be responsible to clean up after your pets, it is the law. Fines will be given for repeated offenders.

<u>Trash Day:</u> Trash should be placed out for pick up after 6 pm Thursday evening. Pick up is every Friday, unless a holiday permits otherwise. Please promptly pick up cans and recycling bins.

Association Fees: Fees are due the 1st of every month, and are considered late after the 11th of each month. Please include unit number on checks. Late fees of \$25 per occurrence will be required to be paid prior to the next month's dues.
