#### LETTER FROM THE PRESIDENT

**This** is the second issue of the year that goes out square-wide to members and non-members alike. Although we like to focus our efforts and funds on current members, we also recognize it is important to reach out regularly to the entire neighborhood with useful information. This issue has reminders on steps you can take to avoid being the victim of a crime as well as a list of common blight violations that can contribute to higher crime in our area.

**Phoenix** District 5 councilman Daniel Valenzuela attended the March meeting as well as supervisor Gabe Ramirez and our inspectors from Neighborhood Services. Councilman Valenzuela discussed his transition into his new position, upcoming city council redistricting and his strong commitment to the neighborhoods and residents of Phoenix. Gabe discussed the city's code enforcement process and provided details on a few active cases. I am pleased we have a good relationship with city staff and am committed to making sure we maintain it.

We have upgraded and redesigned the North Glen Square web site. We have removed all of the confusing advertising, added several new items to the calendar, several new articles, and links to helpful web sites for residents. We also have a new, easier to remember address: www.northglensquare.org. The goal is to make it a one-stop shop for any information residents may need about neighborhood issues. There is also a private discussion board where registered members can participate in discussions with each other on topics ranging from yard sales to lost pets to crime concerns and prevention tips. Check it out.

**The** membership forms from new members and renewed members have been pouring in. Thank you to all of our 2012 members for your support.

#### SRP IRRIGATION PROBLEM

SRP has advised me that there has been a number of irrigation gate operating hand wheels stolen in recent months around the valley. It could be the work of vandals, but, is more likely metal thieves stealing them for sale to scrap dealers. In any event, it is an expensive inconvience to those who are affected and must replace them. It is important to securely tighten the set screws that hold them in place. I advise replacing the square head screws with allen head type as they are less likely to be tampered with.

For your information, even with the wheels gone, you can still operate the gates with large water pump pliers, or a small pipe wrench in an emergency. There is a hexagon nut still sticking up to get a grip on.

Many do not know, but SRP has no responsibility for our irrigation system. They deliver the water to our system at various locations, and it is our responsibility after that. If our system is not in operating condition, they have no choice but to turn the water off. Once turned off, it takes several hours to restore and many down the lne lose their water. Tom Woods

#### **CRIME PREVENTION TIPS**

North Glen Square, like many neighborhoods in the valley, has its share of challenges when it comes to blight, graffiti and crime. To be successful, we need to combat all three problems simultaneously. Overall, we do OK on the first two. While some crimes are inevitable, there are many crimes that are very preventable. Many residents unwittingly make themselves victims by not taking simple precautions. In many cases you don't have to take drastic, expensive measures to protect yourself and your property. Here are some common sense suggestions to avoid becoming a victim of crime.

#If you have a gate to any alley, keep it securely locked.

#Keep sheds and outside storage locked when not in use.

#Keep doors and windows closed and locked at night and when you are away.

#Use security thumb locks on windows.

#Keep your garage door closed when not in use. It only takes a few seconds to snatch an item out of an open garage. Don't give the thieves the opportunity.

#Use timers and motion activated lights when away.

#Use subtle lighting and avoid using spotlights that create harsh shadows.

#Use double cylinder deadbolts on doors with a window. Do not leave the key in the lock or near enough to reach if someone were to break the glass.

#Secure sliding patio doors with a tight fitting wooden dowel in the track or other locking devices. Do not rely solely on the latch that comes with the door.

#Pick up newspapers, mail, flyers or anything else left on your property every day. Have someone do it if you are away on vacation.

#If you live next to a vacant home, help avoid advertising it. Pick up flyers, phone books and other items left at the home.

#Do not leave valuables in your vehicle.

#Avoid parking on the street at night.

#Be aware of activity or cars parked in the driveway at vacant houses.

#Be aware of anyone sitting in a parked vehicle on the street for no apparent reason, especially mornings when people are leaving for work.

#Get to know your neighbors, their cars and when they come and go so you can recognize suspicious activity if you see it.

#Maintain a record of serial numbers, model numbers and photographs of valuables in a secure location. It makes recovery of stolen items much easier.

#Take advantage of VIN etching events, where your vehicle's VIN is etched in the windows. This can help uncover chop shops in the event of theft.

#### ARCADIA DOORS-GLASS PATIO DOORS

If you ever look closely at the locking mechanism of the standard sliding door, you quickly realize how different it is from other locks. They are latches not locks. This design makes them more susceptible to being forced open. Most burglars simply pry them away or "rock" the door until it jumps off track and then can be rolled open. Often these parts are made of plastic vulnerable to cracking or breaking with much less force than you can would imagine. This can easily be prevented by inserting a wooden dowel or stick into the track thus preventing or limiting movement

Other blocking devices available are metal fold-down blocking devices and various devices that can be screwed down. The door rollers should be kept in good condition and properly adjusted. You can also install a pin that extends through both the sliding and fixed portion of the door. All these items can be found at your local hardware store. Place alarm system decals on the glass door near the latch mechanism and remember to always lock the doors and windows when leaving your residence.

#### **Neighborhood Preservation Ordinance** (common blight violations)

The Neighborhood Preservation Ordinance (NPO) is Chapter 39 of the Phoenix City Code. It was established to prevent and address deterioration, blight and/or hazardous conditions that can negatively impact neighborhoods. It provides established mini-mum property maintenance standards for all structures and proper-ties in the city.

**DISPOSE OF TRASH PROPERLY**: Property owners are responsible for keeping their property free of junk, litter anddebris. This includes tires, junk, furniture, building and landscaping materials; liter such as discarded paper, cardboard, plastics, etc.; debris such as tree trimmings and fallen tree limbs; or any other discarded items.

**PARK IN DESIGNATED AREAS**: All parking and maneuvering areas must be dust proofed according to City specifications.

**REMOVE VISIBLE OUTDOOR STORAGE:** Outside storage of personal property at residentially zoned properties is limited to the rear yard behind the primary structure only. Any building or landscaping materials for use on the property, machinery, appliances or parts/auto parts may not be visible from beyond the boundaries of a residentially zoned property. Outdoor storage of items for commercial or business use at a residential property is not allowed.

**MAINTAIN FENCES**: Fencing and screening walls must be structurally sound and made from the same materials. They also must be maintained so that they are free from deterioration and blight. Some examples include fences or walls that are leaning, missing slats or blocks, rotted or damaged.

**REMOVE INOPERABLE VEHICLES**: Inoperable vehicles must not be visible from beyond the bounds of the property. An inoperable vehicle is one that is not equipped with all parts that are required to legally and safely operate on Public streets and/or cannot be driven under its own power. Car covers, tarps, bamboo, shades and other similar types of materials are not acceptable screening.

**KEEP VACANT BUILDINGS SECURE:** Property owners are responsible for assuring all vacant buildings and structures (including primary structures, garages, storage structures, accessory buildings, sheds, etc.) are secured so that windows, doors or other openings cannot be accessed from the outside. A property owner may be required to board up a building/structure to City specifications if it becomes vacant and is not secure. Boarding up a building/structure is a one time, temporary securement option, for a period not to exceed 180 days. Rehabilitation or demolition of a structure may be required under certain conditions.

MAINTAIN VEGETATION: Property owners are responsible for keeping their properties, and the adjacent rights of way, free of dead or dried vegetation (weeds, tall grass, tumbleweeds, shrubs, trees, palm fronds, etc). All dead or dried vegetation must be removed and disposed of properly. Property owners are also responsible for assuring that grass and weeds on their property and in the adjacent rights of way do no exceed six inches in height.


