Heavy Trash Program

The Heavy Trash Program requires that you separate Tree Waste from other types of Junk Waste. The Heavy Trash schedule changes each month from Tree Waste to Junk Waste. Tree Waste will not be picked up if you combine it with any type of Junk Waste. Junk Waste is defined as furniture, appliances and other bulky material (lumber, fence material, etc.). Appliances containing refrigerant must have a tag attached to them certifying that a qualified technician has removed the refrigerant. These items should be placed adjacent to the front curb, easily accessible to the collection vehicle between the hours of 6:00 p.m. the Friday before and 7:00 a.m. on the scheduled collection day (second Thursday of each

month).

Heavy trash put out too early or mixed Tree Waste/Junk Waste not picked up will be reported to 311 and you will be fined by the City of Houston. We need to keep our neighborhood clean.

Deed Restrictions

Keeping our neighborhood clean and free of clutter on the driveways, sides of the house and in the backyards are necessary in maintaining our neighborhood. Trash, overgrown grass, old cars, and wood piles are havens for rodents to live in. Houston is having a serious problem with rodents. and I am asking Gulf Meadows residents to join the fight and clean up around your property. Sidewalks

Sidewalk repair is the responsibility of the homeowner and/or the occupants. Per the following city ordinances: (*Unless caused by city* workers).

Sec. 40-14 – Clearance of tree limbs over sidewalks. The owners and occupants of lots in the city have a duty to keep the tree limbs and branches trimmed to at least eight feet above the sidewalks.

Sec. 40-88 – Permit to construct or repair sidewalks. The repair of sidewalks requires a permit from the city engineer; the permit is to be conspicuously displayed within 20 feet of the work during repair. Code Enforcements at 832-394-9000 issue permits at a fee of \$5.00.
