## **Parking ban to be enforced for 2-inch+ snowfalls**

Parking on all city residential streets will be restricted following snowfalls over two inches, according to Public Works officials.

The program is new for the 2012-13 snow season. Streets will be cleared with larger plows known as "wing plows." Wing plows can clear paths 14-feet wide. This larger path requires vehicles to be off the street to make the equipment as efficient as possible. Therefore parking will be restricted until residential streets are plowed curb to curb.

Snow removal on residential streets citywide will begin when the snow ends. According to city officials, individuals can access up-to-date on snow removal by the following methods:
