Spring cleanup dates announced

The city's annual Spring Cleanup to Remove Urban Blight (SCRUB) Program dates and locations have been announced. Locations and dates are: June 16—Bell Avenue Business Park, 1901 Bell Ave; July 21—Capitol Complex, Lot #3, west of E. 14th, south of Court Ave.; Aug. 18—Southridge Mall, 1111 E. Army Post Rd.; and Oct. 20—Polk County River Place, 2339 Euclid Ave. Hours at each site are 7 a.m. to 1 p.m. A listing of accepted and non-accepted items can be found at: www.dmgov.org.Departments/PublicWorks/Pages/ ScrubGuidelines.aspx. It is possible that the polling place may vary, depending on the type of election, such as school and city elections. Be sure to check during those special elections by verifying with the Polk County Election Office at (515) 286-3247.

Polls are open from 7 a.m. to 9 p.m. for general and primary elections. For other elections, the polls open at 7 a.m. and close at 8 p.m.

To request an absentee ballot, call the election office to request a form be mailed to you. Ballots for primary and general elections are available 40 days before the election. Absentee ballots must have an original signature on the absentee request form, so may not be requested by email. For any questions regarding elections or voter registration cards, contact the number above.
