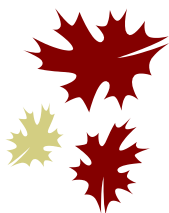

From the President:



It's time to hold landlords accountable for the maintenance and upkeep in our community. Part and parcel of the American Dream, home ownership is a goal to which many in the United States aspire. However, for the 100 million who either cannot afford to purchase their own home, or simply wish to avoid the hassle of repainting that white picket fence, renting remains a vital and desirable housing option. While the U.S. Department of Housing and Urban Development (HUD) has outlined the rights and responsibilities of tenants who live in federal housing, private rental property laws differ by state and municipality. Problems commonly arise when landlords and tenants willfully or unintentionally ignore the law by allowing property to fall into disrepair or by failing to address maintenance issues. This negligence, in turn, perpetuates further, often irreversible decay. Like the proverbial bad apple, one blighted property can spoil the rest of the neighborhood. A careful examination of a nearby street, namely Circle Kelly Jo, leads to a wider recognition of the importance of having a Homeowner's Association to formulate and apply supportive policies to our Association Covenant and By-Laws. When properties begin to rundown it becomes an environment for crime and safety issues. The routine maintenance and upgrades is the responsibility of the homeowner regardless of whether they live in the home or not. As our community ages, it demonstrates the need for upgrading an aging infrastructure and improving the various aspects of housing and environmental conditions, much like overbearing trees and shrubs. It's important to take pride in our homes and community as it is a reflection of you and me.

Meat and Vegetable Kabobs

Ingredients

1 lb. boneless meat, cut into 1-1/4 chunks
2 small zucchini, cut into 3/4 in slices
1 red pepper
1 small red onion
1/4 cup A-1 steak sauce
1 tbsp. lemon juice
2 tsp. dried oregano
4 cloves garlic, minced

Directions

HEAT grill to med-high heat
THREAD meat and vegetables alternately onto skewers.
MIX remaining ingredients; brush onto kabobs
GRILL 12 to 14 mins. or until meat is done and vegetables are crisp and tender. Turn often.
