## MINUTES City of Meadow Vale January 21, 2013

Mayor Fey called the meeting to order at 7:00 PM.

- A. Meadow Vale Resident Guests Comments and Concerns:
- 1) New Commissioner Byron Songer was sworn into service by Notary JDH.
- 2) Paul Just a thank you to the Commissioners for their service to the city.
- B. City Commission Monthly Activity:
- 1) <u>Treasurer Clark</u> presented the city's financial report. The report was reviewed, motion to approve by Com. Borders, second by Com. McAllister. Approved by unanimous vote.
- 2) The <u>December minutes</u> were read and approved with changes to the wording regarding the swearing in of commissioners. Motion to approve by Com. Hornek, second by Com. Borders and passed by unanimous vote.
- 3) <u>Chestnut Ridge-</u> Based upon previous drainage problems and anticipated the City Council of Meadow Vale is opposed to the project known as Chestnut Ridge moved by Com. Songer, Prys second. Motion carries. Passed unanimously.
- 4) Streets: Com. Prys reported no issues.
- 5) <u>VIEW</u>: Com. Prys brought up the previous visit by the Mayor of Hickory Hills.... And the VIEW project. Com. Prys moved to authorize \$2000.00 to VIEW, the Kentucky nonprofit organization for legal and expert fees. Second by Com. Borders.
- 6) <u>Drainage</u>: Com. Prys reported that MSD was in Meadow Vale on January 4<sup>th</sup> working on tree roots in the sewer line at 9811 Lanesboro.
- 7) <u>Safety</u>: Com. Hornek questioned concealed and carry laws. No rules in place on firemarms. Police Activity Report was distributed.
- 8) <u>Lights & Signs</u>: No issues to report. Mayer Fey reported that he has a 20 MPH sign for Hounz Lane.
- 9) <u>Legal</u>: Our city is in need of a five year review of our code book. Counselor Hodge will contact the printing company to get a bid for a review.
- 10) 9805 <u>Meadow Vale property</u>: the bank has filed a suit against the homeowner's lawyers. 9709 Somerford Rd property foreclosure case: new lawyer has been assigned to the foreclosure case.
