Message from the President

How time flies! May is almost half over. We didn't get enough rain this year. So please begin water conservation if you haven't started already. Get in the habit of watering before 9:00 a.m. and after 4:00 p.m. on Mondays, Thursdays and Saturdays.

At last month's meeting, **Jim Kohl** (Environmental Services) spoke about the new household hazardous waste facility on California Ave open the second Saturday of the month from 9 a.m. to 2 p.m. He brought tote bags for everyone. He told us about how to safely dispose of household hazardous wastes. We also had a presentation by **Mike Conway and Martha Long from the Mental Health America (MHA).** The location of the new MHA facility will be on 1900 block of Long Beach Blvd. There were a lot of questions and concerns expressed by the audience. Some were good and some not so good. We didn't take a vote to support or oppose it. It has already been approved by the City Council.

Our guest speaker this month is **Ted Stevens**, **Animal Care Services Manager**. He will bring materials about all the urban animals that have become our pets from the wild. He will also give a presentation on coyotes. (See Pages 4 & 6.)

I have talked to several people about the pending sale of the old Moose Lodge on **2300 Pacific Avenue**). The new owner has applied for a Site Plan Review for a **non-residential Drug and Alcohol Rehab facility**. I have expressed my personal opposition to the Sixth District. There are too many day care operations, schools and churches in that area of Pacific Avenue. On May 1, the WANA Board unanimously voted to oppose it. **At the May 20 meeting, our membership will vote on this issue. (See Page 6.)**

FYI - **Airport Tour**: 25 WANA members that have signed up. The tour will either be on a Friday afternoon or a Saturday in July or August. I will keep you informed.

Building a Better Way to Fly


WANA thanks the Long Beach Airport, and the 6th & 7th District Council Offices for cosponsoring this event.

These young adults pulled out weeds and spread lots of mulch. They even got to the property north of 19th Street. It was amazing to see all of them working so hard.

Nicole Vasquez from the City Prosecutor's Office recruited a dozen Community Service Workers through its program. WANA Board member Jim Trout brought his BBQ and cooked over 192 hot dogs! There were snacks and fruit provided by WANA member donations for everyone.

Job Corps is taking steps to help protect our environment and connect students with businesses and their surrounding communities through community service and green training. Job Corps is preparing students for the green economy through green training in the advanced manufacturing, automotive and construction industry areas.

Critter Corner

The vision of Long Beach Animal Care Services is to become California's safest large city for people and animals through a proactive strategy of community engagement and enforcement activities. The City of Long Beach provides animal care services to four contract cities, including Cerritos, Seal Beach, Signal Hill and Los Alamitos. The annual budget of \$4.3 million is supplemented by over \$2.1 million in revenue collected through donations, fees and contract revenue. Over 50 staff members work in eight program areas, providing 48 key service areas. **In 2012, this department:**

- Completed 63,049 calls for service.
- Increased feline adoptions and redemptions by over 9%, the highest number in 24 years.
- Increased new and renewed pet licenses by 18%.
- Added new cat cottages and puppy condos to improve health, comfort and safety of the animals in our care.
- Collaborated with veterinarian offices in the community to house cats available for adoption in their office lobbies.
- Increased the number of Low Cost Clinics in the Long Beach area by 121%.
- Increased Shelter Veterinarian coverage from five days to six and increased Registered Veterinary Technician coverage to seven days.

Message from the 7th District Councilman

Dear Friends,

The battle continues. By the time you read this, the Los Angeles City Council will have voted on the Southern California Intermodal Gateway (SCIG) project that is on the border of Long Beach. Given that time and time again our voices have not been heard by L.A. regarding this \$500 million project that could have such a profound impact on the western end of our city, I think a positive outcome at L.A. City Council is unlikely. (So far, their offer on funds to help mitigate the negative impacts of their project is easy to remember-\$0.) Nonetheless, this is not the end. I will continue to fight for our neighbor-



hoods on this and other projects, and to ensure that we pursue truly green growth—growth that improves, not deteriorates, our neighborhoods.



This month, I would like to issue a challenge to WANA. I have worked hard to get the money in place to plant 6,000 trees in our side of Long Beach, and I am doing everything I can to get them in the ground as soon as possible. It is important that we not just plant the trees, but that we have a commitment from neighbors who will water the trees in the critical first two years before it has the deep roots to sustain itself. I would love to start planning a tree planting for the fall (when the rainy season begins again) in Wrigley—what do you say? If WANA is up to it, please call my office and let's start organizing for an even greener, more beautiful Wrigley.

Wrigley residents know that our city's infrastructure has long been a passion of mine. In recent years we have made significant progress in tree trimming, street maintenance, and sidewalk repairs, although

more remains to be done. As the Chair of the City Council's Transportation Infrastructure Committee, I will be calling a meeting soon to discuss how we can build on our progress and continue to work on making Long Beach better for current and future residents. Topics will include using new technology that will allow us to more efficiently improve our streets, new techniques for sidewalk maintenance, and how we can better coordinate our urban forest with our sidewalk repair program. Given that available resources are limited, I will continue to work on the Infrastructure Committee to see how we can get the maximum benefit out of every

Sightings of coyotes throughout Wrigley have in-


