ANNUAL MEETING 2012





CAMBRIDGE HISTORY PROJECT

As Cambridge moves into its 60th year later in 2012, a project has been proposed to create scans of any "historic" document you may own about the sub. Do you have any original brochures, flyers, photos, advertisements, clippings, or other memorabilia about the subdivision or its residents? The goal is to borrow these documents and scan them, then return the documents immediately. From this, we can create a print booklet or website. It also would be helpful to be placed in a history file at the public library; other subdivisions have done this.



Detroit homebuilders pick "Ideal 1953 Home"

This contemporary two-bedroom and study-guest room house with 1,576 sq. ft. of living area won an \$800 first prize last month in a contest sponsored by the Builders Association of Metropolitan Detroit for a model to be featured in conjunction with its Home Show next year. Henry

F. Fett, NAHB regional vice president and former head of the Detroit organization, will build the model on a 110' x 120' corner lot in Southfield Township. The contest was limited to Michigan architectural and engineering students. Winner was Richard C. Donkervoet.
