

Who is at Risk?

People who abuse and exploit older people do not discriminate. Their abuse affects people in every segment of society, all ethnic and social backgrounds, and both men and women.

Abuse victims may be your neighbor, your friend, your family member, or YOU!

Most victims:

 Have one or more physical or mental impairments

- Often widowed or divorced and socially isolated
- Usually live with the abuser
- If victims live alone, they fear being institutionalized

Only one in every 14 cases of elder abuse is reported.

By identifying and reporting elder abuse, we can all make a difference.

What is abuse?

Abuse isn't always visible, can happen to anyone, and abusers can often be family members.

Types

- Emotional name calling, insulting, ignoring, intimidating, threatening, isolating, demeaning and controlling behavior
- Sexual unwanted sexual contact of any kind
- Financial/Exploitation the illegal or improper denial or use of money, forgery, theft, and coercion of how to spend monev
- Physical intentional infliction of physical pain or injury
- Neglect deprivation of food, water, medication, medical services, shelter, cooling, heating or other services necessary to maintain minimum physical or mental health

Signs & Symptoms

Abuse can negatively affect your health and many aspects of your life. (continued on Page 3)

- Fear, anxiety, depression, hopelessness, anger, stress, suicidal thoughts
- Unexplained bruises, cuts, abrasions, broken bones
- Not taking medications as prescribed
- Malnourishment and dehydration
- Increased blood pressure and blood sugar
- Insomnia

How to Protect Yourself

Keep your finances in order and possibly get professional help.

Keep in touch with family and friends often. Avoid becoming isolated.

If you are unhappy with the way someone is treating you, speak up, get help, and report it!

The Neighborhoods, Housing and Development Subcommittee, which I am honored to chair, approved a comprehensive roadmap that will guide us in a swift and thoughtful way to reach our goal of becoming a national leader in addressing the issue of domestic violence in our city. Today, I am pleased that this roadmap was approved by full council, and the important work can begin. Domestic violence is a family issue and a public safety issue that affects everyone. What began as a request for special funding for one organization has grown, through a fair and thorough process, into a more comprehensive approach that benefits the entire community. This roadmap includes: increasing community awareness about domestic violence and resources available; adopting best practices in all city operations; reforming the justice system to focus on domestic violence; enhancing coordination of the service delivery system; and developing community partnerships to create solutions. I am pleased that next fiscal year's trial budget includes a new position to ensure this plan stays on track, which is why it is so important to support this year's budget. But we cannot do it alone. Partnering with experts in the community and leveraging the efforts of existing organizations is what makes this plan unique - and what will make this plan a success.

Homes Face Deteriorating Sewer Lines

Any homes built during the 1960's and 1970's have Orangeburg pipe (Bituminous Fiber Sewer Pipe) as the sewer line running from our houses to the city sewer. Made of compressed wood fiber and pitch, it was a low cost alternative to metal for sewer lines in particular. Unfortunately, its softness causes these pipes to fail more frequently than pipes made with other materials. The useful life for an Orangeburg pipe is about 50 years under ideal conditions, but it has been known to fail in as little as 10 years. As it deteriorates, the pipe begins to flattened out and lose its round interior circumference. The flattened pipe can be further damaged by the use of router tools. In addition, the pipes are subject to invasion by plant roots. The plant roots grow within the pipe and eventually restrict or block the flow.

These problems lead to repeated backups of the sewer line from the house to the public sewer in the street or alleyway. Clearing affected sewer lines with mechanical router tools will result in only a temporary improvement.

Many neighbors have received letters regarding warranty policies for your water or sewer line between your house and the street or alley. The two companies are Service Line Warranties and HomeServe USA Corp.

The former has an arrangement with the city of Phoenix (and many other cities) to encourage residents to sign up for water line coverage. Service Line Warranties also offers a sewer line policy for 6.00 monthly = 72.00 a year. However, it currently has a special price of 67.00 annualpremium (till 11/2). This covers up to 4,000 eachservice call but only covers the single main sewer pipe from your foundation to the city sewer line. This includes an additional 4,000 allowance for public street cutting, if needed. (continued Page 5)

Deteriorating Sewer Lines continued......

HomeServe costs about \$82.00 a year (\$6.83 monthly) for a maximum of two service calls with an annual limit of \$7,000 a year. Unlike Service Line Warranties, it includes the branch sewer lines in your concrete foundation from the drains to the main sewer line. Neither policy covers the repair costs to damages in your house caused by or related to the sewer back-up. If considering any of these insurances, also check with your insurance agent to see if your homeowners' or renters' insurance provides coverage for damages due to back-up of sewers or drains. We checked with the city regarding responsibility for sewer line replacement in easements. According to the city, it is responsible for sewer lines in the easements including under sidewalks, alleys, and streets. Contact for Service Line Warranties is 1-855-850-8271, M-F 9-5. HomeServe number is 1-877-444-7730, M-F, 8-8 & Sat 10-4 EST. Our City Councilman Danny Valenzuela has been alerted to this problem of aging sewer pipes in his district to see if the city could map those areas in which Orangeburg pipe was used as the city of Tempe has done. This way homeowners could become aware of the potential of major sewer line problems.

Roving Auto Body Repair Scams = Total Rip Offs

Several neighbors and residents of nearby neighborhoods have reported a variety of auto repair scams being done by people roving the neighborhoods or parking lots such as WalMart's.

These scammers offer a new paint job or repair of a damaged bumper or fender. One neighbor reported the male scammer kept talking to her while his female partner tried to enter her home. Another case involved the scammers fixing a dent by filling it with soap that washed out in a rain storm. Another neighbor reported being approach at a gas station to fix his dented back door of his van. He reported that the junkfilled dent was horrible as it flaked and bled through the cheap paint job. Another report involved the scammer with a sob story about needing money for his family. The neighbor wanted to help so paid him \$250 for what turned out to be a horrible job. The scammer even gave him a card for an auto shop in Glendale. When he called to have the job finished correctly, the shop had never heard of the guy.

Our advice: Report to the police any roving auto body business. Get as much details as possible including license #, description of the scammers, etc. Contact our Cactus Park Precinct at 602-495-5009 and leave voice mails or send emails to: Sgt.
