Presidents Corner

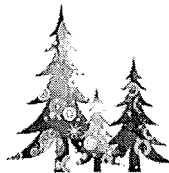

No one home can Win in both categories or win the same place two years in a row. The First Place Winner for the Lighted Displays will be invited to Judge the next year. The rules are pretty simple and the judges look for beautiful, tasteful, and well planned winners, they DO NOT LOOK for the largest amount of lights or the most stuff that is put out.

- Call **Bexar County Animal Control** at **210-207-6650** to have loose Dogs or Cats picked up. They will provide a cage to catch stray cats, and then they will pick up. There is a leash law in Bexar County for both Dogs and Cats. They do have to be registered and licensed. There have been many calls about dogs running loose. **Remember Bexar County has a Leash Law.**
- You are the eyes and ears of your community, if you see any suspicious activity call: **Bexar County Sheriff's Department@ 210-335-6000** To report it while it is happening, you do not have to give your name. Bexar County does have a curfew of 11:00 pm for anyone under 17 and under that is out without adult supervision and Graffiti is a crime and will be prosecuted. You may call this number for a Patrol By. Also call 210-335-4750 for the Constables Pct. 4 for a PATROL BY, so you get both services from two different agencies.
