#### NEW AMUSEMENT BUSINESS IN WESTWOOD

On December 18 the Des Moines Zoning Board of Adjustment has approved a variance and conditional use permit to use the property located at 6220 Grand Avenue for an amusement business to include a go-kart track, a "kiddie" go track, a miniature golf area, baseball/softball batting practice cages, and a zip line structure targeted for children. The board denied any use of the property for a shooting or paint ball gallery. The amusement enterprise will be operated by Ohfir Carmi and is scheduled to open in mid-2014. Staff for the City of Des Moines will be overseeing the project to ensure compliance with city codes. The enterprise is subject to noise ordinance and numerous other limitations. # TRAFFIC IMPROVEMENT COMING AT CORNER OF WELKER AND 51ST

In response to a request from the WNA the city of Des Moines Traffic and Transportation Division has re-assessed the blind and excessively tight corner at 51st and Welker for possible improvements. Presently the corner is too tight for many if not most vehicles to actually turn west from 51st onto Welker without veering into the lane reserved for folks driving east up Welker while at the same time the corner is essentially blind. Following review the city determined that it will rebuild the curb on the northwest corner of that intersection to create a larger radius for turning.

Because there is a storm drain to deal with the corner will still be tighter than most corners, but the change will be sufficient to make it possible for vehicles to make the turn while staying in their own lane of traffic. The city will also be restricting parking on 51st and on Welker immediately adjacent to the corner. The curb work is scheduled for Summer/Fall 2014.

# **URBAN BOW HUNT INFORMATION**

Editors Note: Mike Gaul with DM Parks and Recreation gave a presentation at our annual meeting regarding the Urban Bow Hunt program in which several WNA residents participate. Below is a summary he provided of that presentation.

As a result of citizen feedback on the high deer population, The City of Des Moines has conducted an urban bow hunt for over 10 years to reduce the urban deer population to an acceptable level, NOT eliminate the population. Reasons include reducing the following: car/deer accidents, damage to landscaping such as flowers and trees, and the threat of Lyme disease. With a goal to reduce the deer herd identified, a reasonable avenue to achieve this reduction was an urban bow hunt program, which started in 1998.

To ensure the safety for both participants and public, hunters participating in this program need to attend a one-time bow hunter's safety course, pass an annual proficiency test, apply for a permit and then adhere to a long list of requirements including distance requirements, elevated stand use, cased bow to and from stand, a check-in procedure once a deer is harvested and many more. These requirements, along with the quality participants in the program have produced zero safety incidents for themselves or the public.

If you have a large parcel and would like to hunt your property or have someone hunt it, the process starts by contacting the Des Moines Park and Recreation Department with interest in participating. There is a form to be completed and all adjoining neighbors must be notified. There is also an inspection where distances and other factors are evaluated. If approved, the Parks and Recreation Director will issue a permit for a hunter to hunt your property.

Populations are trending down based on an aerial survey flown each year since the mid 1990's, but other factors may be contributing to the decline in addition to the urban hunt. Because this year's aerial survey of Des Moines Waterworks park showed deer populations to be below goal it suspended its participation in the program for the current hunting season. Des Moines as a whole has not reached the target population but has made progress. # N. VALLEY CONSTRUCTION INFORMATION

The construction you have been seeing on North Valley Drive is part of a pump station project for the Wastewater Reclamation Authority which will help control periods of high flows for the treatment plant. The project will divert portions of the flows coming from Urbandale, Clive, Windsor Heights, Waukee, West Des Moines and Des Moines and send them into a basin just south of Norwalk, where they will be held temporarily until released to the treatment plant for full treatment. Utilizing this diversion and storage of flows will reduce the overloading of the treatment plant and will protect the sewers throughout the system from overflows and damage.

The pump station that is being constructed at the east end of Winona will be under construction until late summer/early fall of 2014. There were three locations within the recreation trail network that were affected by this project, including some temporary closures, regradings, and surfacing. The permanent asphalt surfaces will be placed when the warmer weather comes as asphalt can't be placed in cold temperatures.

#### 63RD AND GRAND BRIDGE UPDATE

It's news to no one that the Grand Avenue Bridge has been reopened. Thank you, Santa! The project, however, is not yet complete as there are still major items to finish as set forth below:

- A temporary gravel trail has been completed beneath the bridge to re-connect the Walnut Creek Trail. Users should be cautious when navigating as this remains an active construction site.
- Project detour signs have all been removed and the police officer at Hanawalt will no longer be present.
- The sidewalks across the Grand Avenue Bridge are not open until later in the spring due to temperature requirements for installation of the epoxy anchor bolts for the outside railing.
- Work continues to progress on creek channel related items with stream banks being reshaped.
- The final trail beneath the bridge, including a large amount of retaining wall, will be completed in spring, which will temporary re-closure of trail.
- Pedestrian railings on the bridge will be installed in the spring, as will approach sidewalks, final site grading, and seeding /sodding.
- The bridge still needs longitudinal grooving installed and West Des Moines may be making modifications to the flood gate.

Remaining work will require occasional lane closures, and, on a couple of occasions, full closure of bridge which city will attempt to limit to no more than one weekend day at a time.
