

VITA sites are now open from January 22 through April 15.


Required Documents

Please review the by-laws below regarding the nomination and election process for our community

As per our By-Laws (September 1979)

Section 4.2 Term of Office. All Directors shall be elected for a term of two (2) years on a rotating basis, with such term to commence on July 1. Two (2) Directors would be elected for a 2-year term at the April members' meeting in odd years, and two (2) Directors would be elected for a 2-year term at the April members' meeting in even years.

NOMINATION AND ELECTION OF DIRECTORS

Section 5.1 Nominations. Nominations for election to the Board of Directors shall be made by a Nominating Committee. Nominations may also be made from the floor at the annual meeting. The Nominating Committee shall consist of four (4) or more members of the Association, one (1) of whom must be a Board member. The Nominating Committee shall be appointed by the Board of Directors prior to each annual meeting of the members, to serve from the close of such annual meeting until the close of the next annual meeting, and such appointment shall be announced at each annual meeting. The Nominating Committee shall make as many nominations for election to the Board of Directors as it shall in its discretion determine, but not less than the number of vacancies that are to be filled.

Section 5.2 Election. Election to the Board of Directors shall be by secret written ballot. At such election the members or their proxies may cast, in respect to each vacancy, as many votes as they are entitled to exercise under the provisions of the Declaration. The persons receiving the largest number of votes shall be elected.

*damage occurs in the lowest spots of the lawn where moisture is most likely to persist into the night




