Confusion has resolution: through the years (17 to be exact) the Fox Canyon boundaries map has taken many shapes. Defunct Crossroads Redevelopment issued one; Nextdoor had another one, Planning, Realtors and the Police all had something that resembled our neighborhood, but dissected us in far too many confusing ways and shapes. All different that the boundaries described in the FCNA's Bylaws and what is to be considered to be our neighborhood. For far too many years (6 to be exact), the Association worked to adjust its boundaries to the true lines. Councilmember Emerald was first approached. She, personally, put us in contact with, now, departing Captain Jarvis, Mid-City, who in turn assigned the job to Police Office Luis Roman, CRO. For the last 4 years, Officer Roman worked pushing the issue steadily forward. A second formal meeting with Captain Jarvis was held; residents' surveys, signatures on petitions, neighbors from other areas wanting to belong, phone calls with community leaders and Officer Roman's concentrated work with the Crime Analysis Unit, finally, produced the map pictured above. At the last month meeting (03/11/2014) Lt. Mat Novak and Police Officer Roman formally presented the newly adjusted boundaries map to the Association. The next day, after the meeting, Nextdoor displayed the new map on the Nextdoor/FoxCanyon network and from now on, steadily, everyone else will adjust their maps to this one. We are THANKFUL to Officer Roman, to Councilmember Marti Emerald, to Captain Jarvis, to Officer Mike Fish (surveyed 49th and lower Auburn), to Cathy McLean (50th Street petition), to Jose (Winona & Sterling Ct., petitions) and to the Crime Analysis Unit. This Team's work brought resolution to the issue and finally put us on the MAP the right way.


LAST MEETING NOTES

The Loop (Auburn/Wightman) Resurfacing

(Asphalt v Concrete)





find the estimated \$500,000 to \$600,000 for the CIP needed to resurface the street on the 2016 budget. The work scope will be to remove all the messed up concrete and re-pour with new concrete. City regulations will not allow any cutting of the new surface for at least five more years after the work is completed. The issues of speeding on the entire Loop, speed humps (both on Auburn and Wightman), the apron at the pork-chop (were lower Auburn meets Wightman uphill), people driving against the way and some configuration to narrow the Loop's entrance/exit at Euclid to stop drivers from making U turns againt traffic were fielded by Julio Rivera, Community Rep to Councilmember Marti Emerald to Traffic Engineering

(TE). We are all looking forward to Julio's report/follow up and to take the issue at the neighborhood level to consider TF's recommendations to slowdown and improve traffic flow on the Loop thereafter. In all, we have a firm commitment from all parties involved and are looking forward to 2016.

THE HOUSE UP ON THE HILL



Again, **THANKS** to Julio's activism on behalf of the Councilmember, the fence at the house on the hill got the graffiti painted over. This house is located in such a way that overlooks 50th St., Landis, Winona, Ontario, the Auburn Creek and Auburn Drive. Graffiti left untouched at this location is bad news because as it can be seen from many different locations and by everyone. As the Ortiz brothers left the neighborhood they made the point to spray their moniker all over the neighborhood including the fence of this house. Association volunteers quickly moved to repaint their graffiti last October (2013). But this unaccessible location made it impossible. About two weeks ago, finally, the graffiti got painted out. **Thank you** Julio.

4th Annual International High School Essay Contest Greetings!

We have launched our 4th annual essay contest to erase stigma associated with mental illness through education. The contest is part of the foundation's mission to address the impact of bipolar disorder and is open to all high school students globally. "Our hope", says Walker, Chairman and Co-founder of IBPF, "is that students will be interested in winning the prize and thereby research stigma in order to write the essay. In so doing, we will be educating a lot of young people and hopefully changing their perception about mental illness". The First Place Winner will receive \$500 and the **Second Place** Winner will receive \$100.

Students may choose one of the following topics:

- How is mental health perceived and addressed in your community, both culturally and socially?
- Disorder?
- How does media impact the stigma of bipolar disorder and other mental illnesses?

Entries will be judged by a panel of authors who write about bipolar disorder and mental illness. The winner will be announced in May, which is Mental Health month. High school students throughout the world are invited to participate.
