Time to Remit your 2014 Annual Dues!

Mail your Farley Neighborhood Association annual dues by October 1, 2014...

It is vitally important for all residents to support our neighborhood by remitting your **\$25 per household** annual dues promptly. Consider some of the services your dues support:

- Promoting better speed control in our neighborhood.
- Working with city and county government to:
 - Maintain our streets.
 - Provide better storm water drainage and improve sewage service.
 - Provide tighter zoning controls and code enforcement.
- Sponsoring, advertising, and placing signs to promote the semi-annual garage sales.
- Coordinating the neighborhood Crime Watch effort.
- Planning, promoting, and holding the informative Annual Farley Neighborhood Association Meeting each year.
- Ensuring the streets are plowed after snow and ice storms.
- Working with IPL to obtain streetlights in un-lit areas.

To continue to receive these services, it is important that your annual dues are paid. Please use the attached envelope to send your check for **\$25** for the **2014** dues to the following address by **October 1, 2014**:

Did You Know...

Responsibilities residents have regarding pet ownership and for being good neighbors are described in the Municipal Codes of Marion County.

Farley board members have received comments about the concerns listed below. Please look through them to see if any apply to you. If so, please make appropriate adjustments; the consequences of continuing the actions may generate costs such as fines and/or payments to the city for violations, or even forfeiture of your pet.

Vaccinations: It shall be unlawful to keep a dog or cat or to provide food, water or shelter for a dog or cat over the age of three (3) months in the city unless each cat or dog is immunized against rabies.

A person's first violation shall be subject to payment of the designated civil penalty in accordance with the Code. A person's second and subsequent violations shall be subject to the enforcement procedures and penalties provided in this Code.

Pets loose in neighborhood: An owner or keeper of an animal is in violation of the Municipal Code if that animal is at large in the city. (*At large* means not confined without means of escape in a pen, corral, yard, cage, house, or other secure enclosure, unless on a leash under the control of a human being.)

The first violation in any twelve-month period shall be subject to payment of the designated civil penalty in accordance with the Code. All subsequent violations in a twelve-month period are subject to the enforcement procedures of the Code and a fine of not less than one hundred dollars (\$100) per violation.

If, while the animal is at large in violation of this section at a location other than its owner's or keeper's property or in the public right-of-way, it:

- (1) Attacks another animal; or
- (2) Chases or approaches a person in a menacing fashion or apparent attitude of attack;

then the violation shall be subject to the enforcement procedures and penalties provided in the Code, and the fine imposed shall not be less than two hundred and fifty dollars (\$250), or five hundred dollars (\$500) if another animal or person is injured as a result of the animal's actions. If the violation results in serious injury to any person, the court upon request shall order the animal forfeited and/or destroyed.

Barking dogs: It shall be unlawful for a person to own or keep any animal which by frequent or habitual howling, yelping, barking, screeching, other vocalization or otherwise shall cause serious annoyance or disturbance to persons in the vicinity.

A person who violates any provision of this section shall be punishable as provided in the Municipal Code; provided, however, a fine imposed for the first such violation shall not be less than twenty-five dollars (\$25); subsequent or continued violations may also subject the owner to impoundment of the animal by a person having authority to impound such an animal.
