GARAGE SALES INFORMATION

As warmer weather approaches, garage sale season will be in full swing. I thought it might be a good time for us to review some rules that apply to garage sales. There are both state and city laws, as well as deed restrictions, that address the sales of items in situations that are commonly called "garage", "yard", "estate" or any similar type of sale. At the state level, an individual is allowed to have two sales within a 12-month period. A third sale is recognized by the state as operating a business. Each day of operation is counted as a "sale day". For any sales on the third day in a12-month period, state law requires that the seller must collect and remit sales tax on all subsequent sales.

The position that the civic club has taken is that residents may have two garage or similar sales in a 12-month period. If the resident conducts a third sale, they may be reported to the state and to the city.

Be aware that our security patrollers keep records on the garage sales that occur in the neighborhood. As a result, if you have already conducted two garage sales in the past 12 months, having a third within a 12-month period may result in a municipal or state citation. Be careful with your dates and there should be no problem with your sales. Good luck, and good weather!

I owe "My Hero" more than words can express and could never repay him for putting his life in danger to help me and my dogs. It is without a doubt, "My Hero" was in the right place at the right time. Thank you from the bottom of my heart.

Many thanks to all of the people in the neighborhood who provided so much support to me during this difficult experience. I am going to truly miss seeing and talking to many of you throughout our neighborhood since I have had to make the difficult decision to take my dogs to a safer place to walk them. I have lived in this neighborhood for over 40 years, and will never put my dogs or myself in danger by walking them in this neighborhood again.

I am writing his letter in hopes that something can be done so this does not happen to anyone else in this neighborhood. There are entirely too many dangerous dogs running unattended throughout this neighborhood.

Thank God for sending "My Hero" to save my dogs and my life!

Heavy Tree and Junk Trash

Heavy tree trash pickup: tree trash, mixed with junk will not be picked up.

Junk trash pickup: includes furniture, appliances, other bulky material (lumber, fence material, etcetera.). Appliances containing refrigerant must be tagged to certify that a qualified technician has removed the refrigerant.

Tree or junk put out too early (before the weekend of the 4th Monday of the month), will be reported to 311 and you will be fined by the city of Houston.

Place for pickup close to the curb, for easy access by the collection vehicle. Place by the Friday before, and no later than 7:00 a.m. on the scheduled collection day (4h Monday of each month). Any Iquestion call 311.
