In Case You Missed It – Notes from April CHNA Membership Meeting

The most recent General Membership Meeting of the Castner Heights Neighborhood Association was held on the evening of Thursday, April 16, 2015 at the Northeast Regional Command Center's Community Room, located on 9600 Dyer Street. The Guest

Speaker that evening was Mr. Gary Sapp, the Executive Vice-President of Hunt Companies, Inc. and President of the Southwest Division of the Hunt Development Group, LP. Accompanying Mr. Sapp was Ms. Tina Wolfe, Director of Commercial Sales/Tenant Recruitment for the Hunt Development Group, LP.

Mr. Sapp provided a brief biography and a quick overview of the Hunt Companies. He then focused his presentation on the Metro 31 development planned for the site of the former Northgate (Northpark) Mall. As outlined in last month's CHNA newsletter, current plans for Metro 31 call for employment of SmartCode development; consisting of 325 units of Class A apartments, 80 units of affordable senior housing and 48 Live/Work units featuring contemporary open floor plans and upscale finishes with resort-style amenities. Mr. Sapp discussed the city's Request for Qualification process, the status of planning, and current design layout. He then led an energetic question and answer period, where among other questions he estimated ground breaking to take place sometime in the first part of next year followed by a 36 month timeline for the buildout. At this point, it is far too premature to announce any proposed tenants. As far as expectations for this type of development, Mr. Sapp noted the success of Montecillo on the Westside; the city's first SmartCode development; can be measured by the fact they are building more units and at a faster pace than they had planned.

The CHNA normal business meeting followed Mr. Sapp's presentation with a review of our quarterly reports, updates on the city's Neighborhood Improvement Program (NIP), UTEP Project MOVE coordination, and opportunities to volunteer for CHNA activities and committees. CHNA President Joe Molinar led discussion of our association's support for the preservation of Castner Range, neighborhood concerns about street resurfacing and a request for increased police patrols, the Great American Clean-up (see article on page 6) and our annual National Night Out celebration (more information on NNO to follow).

The next scheduled General Membership Meeting is planned for 6:30 PM on Thursday, July 16, 2015 at our normal location – the Northeast Region Command Center's Community Room. Lt. Eddie Valencia, Evenings Shift Supervisor of the El Paso Police Department's Northeast Regional Command, has been invited to talk to us about the results of the department's April performance plan in Castner Heights. Our standard business meeting will immediately follow Lt. Valencia's presentation. Hope to see you there.

Why Do I Have to Wait?

We all hate to wait. And it seems like doctor's offices are the worst offenders.

Revealing some secrets along the way, let's first tell you why my patients sometimes have to wait. First, it's my basic drive to stay on time. Getting behind leads to getting behinder. When a given patient's exam is delayed, I feel I owe them more time.



Why the delay? First I don't overbook, but I have to respond to emergencies. I'm the only eye 'emergency room' in the area, so I can't turn anyone away. And some urgent eye situations need urgent attention so those folks go to the front of the line.

Next is discovery of a new problem in a returning patient. Visit time on follow-up visits is carefully programmed to match the patient's condition. A full third of the follow-up patients either notice or I notice something new, and often this new problem demands a comprehensive workup and treatment plan. All this is unexpected.

And last, the "I left my glasses or my medicines at home" or "I left the paper from my family doctor in the car" or "my glasses are in my purse, somewhere....." or any number of "oh, by the ways," or "this will just take a minute." Kinda like the grocery store customer who waits until every last item is scanned before getting the checkbook out and writing a check.

I bet your doctor might say something similar. But we really do try to stay on time and to alert folks when we're not. Sorry about the wait.

Sun Safety

The sun can be one of the biggest threats to outdoor recreation enjoyment. Too much sun can give you painful sunburn, cause heat exhaustion, or lead to heat stroke. Sunburn may also cause long-term skin damage - even skin cancer. You can reduce the risks of too much sun by following these simple guidelines:

- Build up your exposure gradually
- Use a sunscreen product
 - o Higher Skin Protection Factor (SPF) ratings provide better protection
 - o Reapply sunscreen after swimming
- · Plan activities to avoid the sun when it's the strongest - from 10 a.m. to 3 p.m.
- Wear a hat and clothing that cover as much of your body as possible

Sun intensifies when it reflects off sand, water, and concrete.

You can get burned even when it's overcast or foggy. If you do get sunburned, rinse or soak in cool water or use cold compress. If you have a mild sunburn with no blisters, use a gentle, non-medicated cream. See a doctor for severe, painful sunburn.

Beyond this place of wrath and tears Looms but the Horror of the shade, And yet the menace of the years Finds and shall find me unafraid.


It matters not how strait the gate, How charged with punishments the scroll I am the master of my fate: I am the captain of my soul.



Vietnam Veterans' Memorial Slated for Castner Area



Flags Across America, an honorary Castner Heights Neighborhood Association Member, plans to host a Vietnam Veterans Memorial at the Old Glory Flag Site, 9550 Gateway North at Diana Drive. The memorial was designed by retired Sergeant Major Joe "Chinaboy" Lopez, who along with several of his friends formed a tax-deductible 501 C (3) nonprofit organization, called the Vietnam Veterans Memorial organization, to raise \$50,000 for creation and installation.



The design calls for wing-like wall, 8 feet high and 48 feet long that will include the names of Vietnam Veterans killed in action or missing in action who are from El Paso County. Local sculptor Julio Sanchez has been selected to create the memorial.

Jesus Vera, another Vietnam veteran from El Paso and president of the Vietnam Veterans Memorial organization, said people who donate \$250 or more will receive a plaque that commemorates Vietnam veterans. 


