2015 Drug Take-Back Day



The DEA has announced that the 10th National Drug Take-Back will

take place across the U.S. on Sept. 26 (except for PA and DE). In Maryland drop-off locations will operate from 10:00am-2:00pm on that day. The DEA, is encouraging people to clean out their medicine cabinets to make sure their home is safe from drug theft, misuse, and abuse of unwanted, expired, or unnecessary medicines. In the previous nine events, 2,411 **tons** of drugs were collected.

Sites will be set up nationwide to turn in Rx or over-the-counter drugs for safe disposal. Local collection can be found at www.dea.gov, or see "Calendar" or "Documents" sections of www.manorlake.org.

Montgomery County locations will **not** accept liquids, illicit drugs, needles, sharps or syringes as part of this program.

Buried in Paper?

Montgomery County hosts several drive-through paper shredding events during the year. For safety reasons, you must remain in your car and cannot watch your paper being shredded. 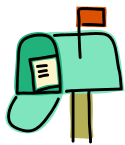

REMINDER: Mail Fraud & Property Theft



We receive occasional notices from residents regarding theft of mail/packages, or items from property and cars. A few suggestions for residents:

- Do not leave important outgoing mail in your mailbox, or raise the flag to indicate outgoing mail.
- Deposit mail in a blue collection box or inside your local post office.
- Promptly pick up your mail after it is delivered.
- Be observant of activities on your street
- Keep your homes and cars locked and valuables out of sight.

If you see suspicious persons or activity, call 911 while the suspects are still present.

Manor Lake Bulk Item Pick-up Scheduled



Two years ago, your Manor Lake Civic Association began organizing a twice-a-year bulk item pick-up service, **free for MLCA members**.

This event has become an eagerly awaited method to dispose of items that have outlived their usefulness or aren't easily recycled.

Two trucks come through Manor Lake; one for trash and the other for recyclable material. MLCA members may participate **once** during the year **for free**. Due to popular demand, residents who have already used their free pick-up may participate a second time for the nominal fee of \$5 per house.

MLCA Membership and Newsletter Updates

The 2016 MLCA membership drive begins NOW! In response to the community about membership dues time frame, the Board has voted to *change the fiscal year* from Oct. 1 – Sept. 30, to the standard calendar year of Jan. 1 – Dec. 31 (while the fiscal year is not included in the MLCA bylaws and therefore not subject to community vote to change, discussion time will be allowed at the September general meeting). Membership for Q4 2015 will *be included* in the 2016 membership dues.

All those paying their dues by December 31, 2015, will be entered into a drawing for a \$50 gift card (to be awarded at the May General Meeting).

We continue to hear remarks from residents about neighborhood pets; therefore, we will continue to print a few reminders to Manor Lake dog owners. Be a good neighbor while walking your dog: Adhere to leash laws; keep pets off others' property whenever possible. Although the street-side of your property belongs to the county as access, owners must still mow the lawn and it is not nice to be stepping in doggie doo so if your dog "doos," please pick it up. Remember that dog feces are an attraction to rats, so remove them from your yard as it could pose a health hazard.

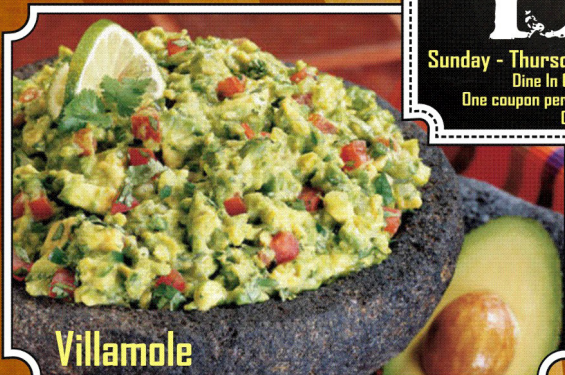

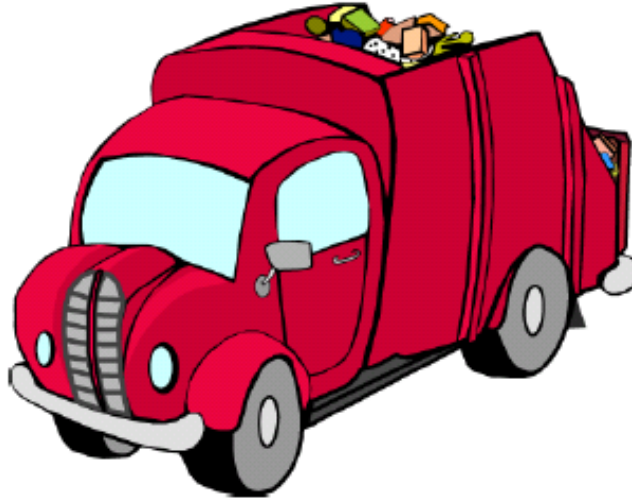
