# Trimming Vegetation Away From Sidewalks, Street Signs & Lightpoles We Are Good Neighbors

As fall sets in it is time to take a look around our property and see if any landscaping needs to be trimmed back and cleaned up. Sometimes a small bush seems to explode with growth over the summer season and now it has encroached onto the sidewalk. Maybe your front or side yard tree has begun to stretch over the sidewalk and is now hanging a bit too low for walkers to travel underneath. Those homeowners who have backyard fencing adjoining a major neighborhood street & sidewalk, take a look at the backside of your property. If you have a fruit tree that has decided to drop it's fruit and it is landing on the sidewalk, it could be time to trim it back also. Some corner lots may have street signs that have become covered by foliage, please trim it away to allow for proper vehicle travel. Also,



please keep in mind that corner lots need to have a visual site line to allow for traffic flow. This means that landscaping should not be any higher than 36" on a corner. A few areas in Columbine West have seen trees that are growing up and around street lights. If zoning is called out to address the tree trimming issues the homeowner will be assessed a fee from the County. In the Winter time it is not usually

noticed, but during the summer when the trees have leafed out, lighting of the streets can be compromised. For the safety of all neighbors we should try to keep the lights clear of branches. As the leaves begin to fall, please try to collect them before they end up in the streets and gutters. Leaves make great compost material, mulch for flower beds and stuffing for frontyard Halloween scarecrows. Keeping the gutters clear can also aid with rain and snow run-off and help to fend off ice build-ups. Neighbors new to the community usually comment first on how nice it is to have mature trees and landscaping, followed by questions concerning why a homeowner has not cut down a dead or dying tree. If the tree has no more life left to it and is possessing a concern of falling down and damaging property, maybe it is time to call in the professionals. Homeownership has its priveledges and its expenses. Thank you for taking the time to keep everyone safe within Columbine West. The association strives to see our community defined by a sense of shared ownership and collective responsibility. #### Lawn Tonic for a Greener Lawn

The 'Lawn tonic' idea has been written about in books and used in Colorado, where we have been experiencing water shortages in the past years. "When you don't have a lot of water and are asked to help conserve and practice 'watering restrictions', there is another way to get the nutrients to your lawn and keep it growing. The secret formula is actually just a mix of common household ingredients. All mixed into a 10-gallon hose end sprayer. Each ingredient does something different, it feeds the lawn, penetrates the roots and promotes growth, and even kills bugs and grubs.

### Recipe:

One can of soda-not diet, one can of beer-not light, ½ C. liquid dish-washing soap (don't use anti-bacterial soap), ½ C. mouthwash, ½ C. household ammonia. Mixed in a 10 gallon hose end sprayer. \*\* Apply every 3 weeks. Mow lawn in evening then make application. Note: A ten gallon hose end sprayer does NOT contain 10 gallons of liquid. It is a sprayer with a reservoir that attaches to your garden hose, and when the reservoir is full, mixes evenly with ten gallons of water that flows through the hose.

### (Covenant Corner) Covenant C-7 Signs

(Covenant B-9 for those in the Columbine West Hillside Addition):

"No sign of any kind shall be displayed to the public view on any lot except one professional sign of not more than one square foot, one sign of not more than five square feet advertising the property for sale or rent, or signs used by a builder to advertise the property during the construction and sales period." Zoning: Section 11 Signs and Outdoor Advertising Devices

B: General

- 1. Regulation
  - b. No sign shall be placed in the right-of-way of any public street/road or highway except as specifically provided for in parts of this section of this Zoning Resolution.
  - D: Signs or Advertising Devices Not Requiring Permits:
  - 8. Political Signs: Signs which do not exceed 6 square feet in area that announce the candidacy for election to various governmental offices or state a position concerning political issues. These signs shall not be placed in public rights-of-way, on public utility poles, or placed on private property without permission of the landowner, shall not be illuminated, and shall be removed within 10 days after the day of election to which they pertain.
  - F: Specific Zone District Sign Regulations
- 2. Residential Zone District R-1
  - a. maximum number of signs per lot: One single or double-faced sign.

Section D-8 above also applies to garage sale and lost pet signs.

### **Senior Hunger**

#### **Senior Hunger Fact Sheet**

The number of older adults is projected to increase over the next decade and continue to rise in the following decade. In 2040 there will be 79.7 million older adults, more than twice as many as in 2000. Additionally, the senior population is becoming increasingly diverse. Between 2012 and 2030, the white population of 65 and plus is projected to increase by 54 percent compared with 125 percent for older minorities.

These changing demographics will have profound impacts on the demand for social services, especially the need for adequate and culturally appropriate nutrition services. Seniors may have unique nutritional needs and challenges that separate them from the rest of the population and must be considered.

#### **Charitable Food Assistance**

Seven million seniors (age 60 and older) are served by Feeding America each year, as well as nearly 6 million older adults ages 50 and 59. Thirty-three percent of client households have at least one member who is age 60 or over, and 76 percent of these households are food insecure - an estimated 3.9 million households. The food insecurity rate increases to 81 percent when including households with a member age 50 and older.

Among all clients served by Feeding America, 17 percent are seniors age 60 and over and an additional 15 percent are between the ages of 50 and 59.

Among all food programs in the Feeding America network, 12 percent of meal programs, such as home-delivered meal programs (or Meals on Wheels) and 7 percent of grocery programs, such as senior brown bag programs, are targeted for seniors.

Three out of four (76%) client households with at least one senior report planning to use a food program in the Feeding America network on a regular basis to assist with their monthly food budget.

Among client households with at least one senior, 47 percent report that a household member has diabetes and 77 percent report that a household member has high blood pressure. Likewise, two out of five (41%) client households with an adult age 50 and older have at least one member with diabetes, and more than two-thirds (70%) of client households with an older adult have at least one member who has high blood pressure.

Thirty percent of client households with at least one senior report having a member that has served in the U.S. military. This number is slightly lower (approximately 27%) when including households with a member(s) age 50 and older. Today, Feeding America is the nation's largest domestic hunger-relief organization—a powerful and efficient network of 200 food banks across the country. As food insecurity rates hold steady at the highest levels ever, the Feeding America network of food banks has risen to meet the need. We feed 46 million people at risk of hunger, including 12 million children and 7 million seniors. 
