The meeting was convened at 6:54 p.m. **Diane Suchomel, Vice President**, welcomed everyone.

**Special Reports – Captain Allen Simmons, Jefferson County Sheriff's Department**, said that how the response time is calculated has changed. The time starts when the dispatcher takes the car and ends when the car arrive at the location. Last month the response time was 7 min., 52 sec. There were 299 Priority 1 calls in Sept. That was down 16% from Aug. Since Sept last year, overall crime was down 2%. However motor vehicle trespass is up 8%.

There were 47 back flow preventers stolen in 2 weeks. They made 3 arrests.

There were several motor vehicle trespasses south of Bowles and east of Kipling. Burglaries are up 25% north of Bowles and west of Kipling.

Have there been a lot of activities at the schools? There have been a lot of custody disputes. A parent forgetting to pick up a student.

Columbine has had several fake bomb threat calls.

Southwest Plaza is almost done renovating. They expect more traffic starting in Nov. 14 when they re-open. They are asking for extra deputies to work while off-duty.

No one from **Foothills Parks and Recreation District** was present.

No one from **Jefferson County Public Schools** was present.

Tonight's speaker was **Julie Rist** from **Jefferson County Public Library**. She wanted us to know that she was attending as a private citizen and Library volunteer.

It has been 29 years since the mil levy has changed. The population has increased 30%. There are 550K residents in the district. They have 34% more library card holders. They have 6M items for check out. They have 1.8M visitors a year. They have done a lot of cut backs already.

There is an item on the ballot to increase the mil levy by 1 mil. This would cost the average homeowner \$1.95 per month. They have polled the community asking what they want, what they want to keep, and what they want to get rid of. The result will be analyzed by a committee of 74 people.

The current budget is less than what it was in 2008. They have reduced their hours twice. They have reduced their staff. Some days they open and close early. Some days they open and close late.

If the mil levy is approved, they will go back to normal hours; increase their materials budget; update their technology; and repair their buildings and finances. They based the levy increase on their 5 year budget plan and 10 year forecast. Julie distributed yard signs.

What does the paragraph mean? The library proposes that the money collected from the mil increase can only be used for the library and it removes Tabor restrictions.

How is the budget set? Their Board is conservative. The budget is also approved by the County Board of Commissioners.

Will the levy increase be used to build new libraries or just maintain existing buildings? The first 5 years the money will only be used to repair, plan, and stabilize. Then they will save and look at expansion possibilities. The under served areas are in the south part of the county, northwest around Stanley Lake, and Arvada.

Is there still a Book Mobile? Yes, it runs on Saturday for 4 hours.

How many attempts for a levy increase has been tried in the last 29 years? The last attempt was in 2000.

Jefferson County Public Library is in the bottom quartile. We really want to be better than average for our community.

How do you respond to Why are Libraries needed? When you do a Google search, there are too many responses and the responses change based on how you ask the question. As digital literacy increases, citizens need to differentiate good information from bad information. Studies have shown that there is a difference in retention between reading something from paper and a digital source. It is better than reading it from paper. A city in Texas went to a all digital format. They have been open for 6 months. Our library personnel are watching it.

The Library is still the "People's University".

**Tori Merritts** asked to speak to us. She is running for the open District 4 School Board seat. District 4 is mostly in Lakewood. Whether you do or do not vote for the recall, you can still vote for the replacements. District 1 has 1 candidate. District 2 has 2 candidates. District 5 has 3 candidates.

**Reports from Officers** Roll Call was taken. We had 12 members present and we have a quorum.

We do not have a President.

**Ray Moore, Treasurer**, was present. We have \$1,654.57.

**Cheri Paavola, Secretary**, was present. The Minutes for September were approved.

**Diane Suchomel, Vice President**, was present.

Out Adopt a Highway event will be Oct. 17, Sat., at 8:30 a.m. We will meet at the West Bowles Community Church.

The property at 8290 W. Coal Mine has a rezoning application. They are proposing a 2-story senior living facility with 80 units. This is the property where the dog kennel is.

A 12900 sq. ft. clinic has been proposed near the CVS Pharmacy at the southwest corner of Kipling and Bowles. The site development plan is on the county website.

The Fun City location is planning on medical buildings, which they are already zoned for, and a separate standalone Emergency Room, which they are not zoned for. They will need to go through the rezoning process for the ER.

Construction has started at Simms and Bowles, by the Rite Aid.

Celebrate National Pro bono Week is on Oct. 29, Thurs., from 9:00 a.m. until 3:00 p.m. You can meet with an attorney for 15 min. on topics such as divorce / custody, tenant / landlord, eviction, small claims, criminal / juvenile / traffic, and cases about money. It will be held at the Jefferson County Court House.

There is a pre-application for the southwest corner of Coal Mine and Pierce. They will be having meetings with area HOAs. It is now zoned as agriculture. The time and place are TBD.

Our November meeting will be at Lilley Gulch. Our speaker is from Habitat for Humanity.

Diane has filed our request for the meeting room at the Jefferson County Sheriff's South Precinct. Elections still get the first choice.

**Old Business** The position of President for COHOPE is still open.

**New Business** None.

**From President's Corner November 2015**— It's nearly time for our mid-term elections; I hope you are involved. Make your voice heard - GO VOTE. Realtors say that they often include information for prospective buyers about neighborhoods that have exceptional parks and schools. That would be much better than receiving a notice from Jefferson County roads.

By the way, someone HAS been sending letters to neighbors about issues - and using the Columbine Hills Civic Association board as the source of the warning letter. At this point, we have not sent out any such notices; it disturbs me that someone would do that! If the letter is not signed by me on official Columbine Hills Civic Association letterhead, it is a false notice. I have gone to the recipients and apologized for something we haven't done. I enjoyed meeting folks, but not in that way. Speaking of meeting folks, one of our community members hosted a street party last week on Ken Caryl Place, I was invited to attend and enjoyed meeting a number of you. Animal control does not endorse any particular service or company and strongly recommends that consumers check references, licenses, insurance and bonding before hiring any company. **Treasurer's Report** – The Treasurer's Report and bills to be paid were submitted by Donna. Property tax revenue and ownership tax revenue funds were reported. **Parks Manager Report** – Dave reported the Platt Canyon C-Line contractor will back in to re-seed the trail to the old potty. Concrete repairs should take place soon on damaged areas by the same contractor. Dave and Board members are researching bee keepers that may be interested in removing bees from one of the logs from a tree recently cut down. The first attempt did not remove all the bees. This needs to happen by September 29 since the contractor will be removing the logs from the park at that time.

Organic fertilizer was spread on the bluegrass for the second time and broadleaf control was done also. Lots of low hanging branches were trimmed and more needs to be done.
