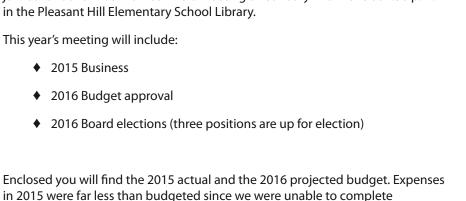

Updating Our Bylaws

This year the board reviewed our existing bylaws, neighboring associations' bylaws, and considered a wide range of changes. Potential changes were mailed out for each of us to consider, and many of you came to a townhall-style meeting where we had the opportunity to listen to one another on this important issue.

The board reviewed all comments provided, both written and verbal. There was merit to so many, and these were taken into consideration. After editing the proposed changes, they were presented to our legal team. It was at this point we became aware of a requirement to notify every active lean holder of our intent to change the covenants and bylaws.

Notifying lienholders is an expensive and laborious process. We received a quote for \$3,500 to meet this requirement. Of course such an expenditure should be approved in the budget process, and was not considered in the 2015 budget. Having neither the time

to start the process before year's end nor budgeted money to proceed, the process has been delayed. It will become a matter for the new board to consider in the new year.

Thank you all for your support, interest, and involvement in this process over the past year. Last year we requested that you 'lend your voice to the process,' and you did thank you!

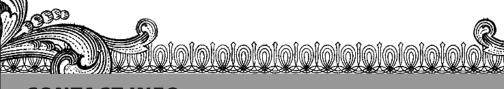
