### ITEMS OF INTEREST

Tennessee is now the first state to offer a published animal abuse registry. The TN Bureau of Investigation opened the list on January 1st on its website, www.tn.gov/tbi/topic/tennesee-animal-abuse-registry. First time offenders' names will appear on the TBI list for two years after conviction. People convicted before January 1st are not listed on the website.

Anyone has the right to report violations or concerns by calling the City of Millersville (615-859-0880).

Our Community is bound by and must also adhere to the Leash Law. All pets (dogs and cats) are not to run at large and must be on a leash. Any pet found running at large may be seized and impounded. Anyone has the right to contact the Sumner County Animal Control Office at (615) 452-2400.

Please be respectful of your neighbors when walking your dogs - ALWAYS carry a bag with you and ALWAYS clean up after your pets.



### THE FINE ART OF PARKING

Remember to park in driveways and garages at all times. If you or your guests must park on the street, pursuant to Section 78-111 of the Millersville Code, you must park in the direction of traffic and within 12" from the curb.

NEVER block your neighbor's driveway, mailbox or trash bin.

PLEASE DON'T EVER park on or in your neighbor's yard.

Cars are not permitted to park in yards.

Remember ... you are always taking a major risk if you park on the street!

Your vehicles could very well be damaged without your knowledge.
