# Municipal Bond Proposals Presented

During the last JNA meeting **Anthony Chukwudolue**, and **Razi Hosseini** both Assistant Directors from Transportation and Capital Improvements (TCI) discussed the new 2017 Municipal Bond.

JNA members heard the new City Bond for 2017 is anticipated to be for \$850 million dollars. Survey findings taken from City residents concluded that their most important area of concern is infrastructure. Residents want Sidewalks, streets, curbs and flood control. This bond will also assist the estimated 1.1 million new residents to San Antonio by 2040. Last year San Antonio combined with New Braunfels witnessed an influx of 50,000 new residents.

This will be the largest bond in the history of San Antonio and fortunately historic low interest rates combined with the City's triple A rating will help in obtaining low interest rate loans. Property taxes will not be raised. In May 2017 City residents will vote for both the SAISD Bond for \$450 million and the City Bond. It is to go before City Council for a vote on September 17. City Manager **Sheryl Scully** reported: "The bond program is how we make those big capital investments."

"The bond covers five categories: streets, bridges and sidewalks; drainage and flood control; parks; facilities, like fire stations and libraries; and a new proposition called neighborhood improvements, a category that could include money for affordable housing... This would be the first time affordable housing would be considered for the bond, although officials say there are potential roadblocks to the types of housing programs originally envisioned."

CTI reported that there will be a onetime project for corporations such as SAWS, CPS, and VIA.

Before officials begin publically vetting potential projects, the council must appoint committee members to five bond over-sight committees which will help craft the list of projects put before voters next year. #### Message from Marie



A recent article in the Beacon Hill News describes a zoning controversy that the Beacon Hill Neighborhood Association is going through. Since Beacon Hill is so close by and since we in the Jefferson Neighborhood area are in the midst of similar plans for redeveloping the Fredericksburg Road area, the disagreement is instructive.

The problem began when the city zoning commission permitted a developer

to put a Stripes convenience store on the corner of Fredericksburg Rd. and Woodlawn. **Cynthia Maria Spielman**, president of the Beacon Hill Neighborhood Association, then filed an appeal to the City alleging misinterpretation of BHNA's Conservation District standards. The property developer then threatened to sue if she did not rescind the appeal and warned that litigation would be an expensive and lengthy process. The **Tier One Neighborhood Coalition** (T1NC) came into existence in direct response to that threat. The coalition is comprised of several non-profit neighborhood associations inside Loop 410. This coalition has had a beneficial effect in bringing together these groups in a common cause: that of ensuring that neighborhood conservation standards are appropriately considered and maintained. With significant development coming in, adherence to these standards is central to maintaining our neighborhoods' character as our city grows.

T1NC immediately began working to research areas of the **SA Tomorrow Comprehensive Plan**. Their research determined that the city planners had not included neighborhoods with conservation districts and the standards associated with them. The plan mainly addressed population growth expected by 2040 and proposed goals to accommodate that growth. T1NC suggested several revisions to the Comprehensive Plan to protect neighborhoods with Neighborhood Conservation Districts and Historic Districts.

T1NC held a meeting with Mayor Ivy Taylor, Councilman Cris Medina, District 7, and Councilman Trevino, District 1. The need for revisions to the Comprehensive Plan were stated. The City officials listened, and the Mayor mentioned not being aware of the lack of inclusion of neighborhoods in the planning process and seemed to understand the importance of revising the plan. On 8/11/16 city council voted in support of all neighborhood amendments set forth by the T1NC. The following are the end result of the revisions.

"T1NC accomplishments:

- a. "Inclusion: Any future update will include resident and stake-holder input as the Comprehensive Plan is a community-based plan."
- b. "Neighborhoods: SA Tomorrow recognizes the importance of our existing neighborhoods. These treasured assets are the foundation of our city and will continue to play a critical role in our future planning efforts. The growth strategies recommended in this plan protect and enhance these valuable parts of our City by focusing many of the new housing units and jobs into the other building blocks. By investing in our neighborhoods, in conjunction with strategic planning in our corridors, urban centers, and regional centers, we ensure the ability to create and support complete communities across our city with access to a variety of amenities and daily needs and services."
- c. "Neighborhood Conservation Districts/Historic Districts: For example, existing historic districts and neighborhood conservation dis-

tricts are not recommended for higher density development and should receive enhanced protection to prevent this."

- d. "Where appropriate: Incentivize high density housing in regional centers, and along public transit routes where appropriate."
- e. "Stormwater Inside Loop 410: NRES Policy (under Stormwater Management): The City should address the impacts of stormwater run-off from public facilities and schools to protect adjacent neighborhoods."
- f. "Implementation: The community and stakeholder engagement process should include a minimum of: a Steering Committee with representation from each neighborhood, including all registered neighborhood associations, within and adjacent to the Regional Center..."
- g. "The plans: The Community Plans should integrate and will eventually incorporate two plan types from the 2009 CPP, neighborhood plans and community plans" "The size was reduced from 15 square miles to 5."

h. "The Buffer Zone: Establish appropriate buffers and transitions (land use, form and/or landscaping) between residential neighborhoods and surrounding higher density development."

I would like to thank all the members of the T1NC for their passion and dedication in securing input by the community in future revisions to the Comprehensive Plan and all other amendments made for safety, saving our neighborhoods, environmental issues and buffer zones.

I am honored to be a part of this alliance and I want to thank everyone who supports us.

I want to also thank the public figures who rallied when they heard what had occurred and provided information concerning SLAPP, a Strategic Lawsuit Against Public Participation which protects frivolous lawsuits used to intimidate and silence opposing voices with threats of expense and lengthy litigation. Texas has some of the strongest anti SLAPP laws in the country and through the Citizens Participation Act (TCPA) makes it easy to have suits dismissed. **Senator Jose Menendez**, District 26, and **State Representative Bernal**, District 123, provided this information.

Please stand up for your rights and speak up!

At the next JNA meeting, Sept 12, VIA will give a presentation, and a SAISD representative will speak on behalf of the \$450,000,000 proposed bond. The City did not go into specifics about the SAISD bond during the last meeting.










## **Jefferson Neighborhood Association Boundaries**
