

#### **Warming Up to Weather Activities is Cool**

We had a late frost in October then a month of warm weather before the real cold started. The temperature went from 80 down to about 0 degrees in one day just after Thanksgiving. People were rushing to get their sprinklers winterized. I finished most of my outside work, but there are still some leaves on the trees. They seem to be falling later this year. October and November were mostly dry with very little snow. Now our thoughts can turn to Holiday season and yes, wintertime. I know many of you dread the thought of fighting with the cold and snow. It means we have to drive in it and someone has to clear away the snow. City code requires that the snow be removed or the home owner could face fines. Snow and ice must be removed within 24 hours after a snowfall ends, and 48 hours after a snow emergency is declared by the city. ### **Annual VENA Meeting Provides Civic Interaction Opportunity, Light Rail Update**

Our annual meeting was October 11th at 7:00 pm at the Village East Elementary School. It was an opportunity to catch up on things in our neighborhood and to discuss any concerns you might have had. We had a guest presentation about the progress of the light rail and they expect to have the Aurora link done sometime next spring. The opening has been delayed because of

the problems with the crossing gates on the line out to the airport. We also had a presentation about the status of Aurora from our City Council representative, Charlie Richardson. Greg Toler continues as Vice-President and Linda Metsger as Treasurer. Our secretary is Ann Dougherty and Arnie Schultz has rejoined the board. We will be continuing the Holiday Lighting Contest, Yard of the Month Contest, Spring Cleanup and the Adopt-A-Street program. We have Officer Dan Southwick (303-739-6951) as our PAR Officer. We have been posting our newsletter on our website and sent out a printed newsletter just prior to the annual meeting. We will also be posting the newsletter on Nextdoor Village East. The meeting was attended by about 20 Village East Residents. Our current membership is about 75 homes.

The condition of the neighborhood in general is very good. We have a few vacant homes or under foreclosure. House sales have picked up a little again. Many homes could still use improvement. Every home a visitor in our neighborhood notices forms an impression of our community. Collectively, we would like to show visitors how nice our neighborhood really is. It takes everyone's cooperation to project this image. If you live near a neglected home, please call code enforcement (Access Aurora – 303-739-7000) and report the situation or be a good neighbor and help out yourself. ## Behind the City Scene

### November -

It is that special time of year, and no I am not talking about the cool evenings and the leaves turning and dropping! It is City budget time. During the City Council meeting of October 10 the City Council adopted the 2017 budget.

Here is how the process works. In mid year the City Manager proposes the budget for Council review. Then a "Workshop" occurs in late summer on a Saturday. The proposed budget is reviewed Department by Department. A Council Member can make a Motion to either add or delete something. It takes 5 votes to list the action up on a whiteboard. At the end of the day the Mayor asks for votes on all the whiteboard items. If there are 6 votes, which is a majority of the 11 member Council, then the action is considered to be formally incorporated into the Budget documents. This year there were 9 items added to the budget during the Workshop. I voted for only 2 of the nine. These 2 items related to adding 5 more police officers and providing stop signs (\$600) for an intersection in Ward 3.

I was unsuccessful in proposing the elimination of a \$100,000 study to determine how many police officers we should have. I am not a big fan of studies like this because, very candidly, the results almost always reflect the preferred outcome of the sponsor of the study. Currently the minimum ratio of police staffing is 2 officers per 1,000 population. This is mandated by a previous ballot issue. The City Manager's office, in my opinion, opposes this mandate on the grounds that the number of police officers should be the prerogative of City Management and Council. The problem I have is that the mandate is a result of a vote by the people and I have no problem with a "floor" of required police officers. Public safety including both police and fire is "Job 1" for local government, followed very closely by adequate maintenance of our streets which is a, "Pay me now or pay much more later" paradigm.

Of the 7 items I did not support, one item really upset me in terms of an outrageous misuse of tax payer money. The expenditure sponsored by a member of Council is ten thousand dollars for "Buskers, Brews and BBQ". Some might say, "It is only ten thousand dollars." In Washington DC it would be, "It is only 10 million dollars." That sentiment is wrong here just as it is wrong in DC! I don't mean to sound uptight but I'm also not comfortable with

public funds being used for the purchase of alcohol. There was only one adjustment when the budget was adopted. A fellow Council Member proposed, and I supported, seven thousand dollars to create a low power radio station in Aurora to serve immigrants and refugees from Africa with pro-democracy news and information to help them successfully assimilate into our country. For example, in many African countries, the police are much feared for very legitimate reasons.

#### December -

When I was growing up in the 1950's the terms describing homeless individuals were: "vagrants," "tramps," "hobos" and the like. These pejorative descriptions have been thankfully replaced with terms such as "urban travelers" or just "homeless". However, the phenomenon remains and has exhibited itself in Ward 4 especially along and around South Havana.

Of course, there is a fierce debate as to the causes, ranging from unexpected and unanticipated events to a free choice. In my opinion, there is a spectrum of causes in relation to each individual. Mental illness, illegal drugs, alcohol, domestic violence, loss of employment and aversion to living in main stream society. Some have suggested that marijuana legalization has contributed. With several states including California now voting to legalize marijuana it will be interesting to see if there is a decrease.

This column is not intended to address causation. The City of Aurora has initially committed to spending approximately 1.5 million dollars each year for 3 years from the marijuana revenues. The City Council has authorized the furbishing and opening of a day resource center up on the old Fitzsimmons campus. The Center will provide a wide range of services including counseling of all sorts and activities. In addition, there will be 2 "HOT" vans put into operation. These vans will be utilized to contact homeless individuals and offer transportation to the Center. The homeless person will obviously need to voluntarily get on the van.

I was the ONLY Council Member to vote against the above. Here is why. The Center closes at 5 pm. Furthermore, I have just received confirmation that the "HOT" vans will, upon request, return individuals to their original location. I recently spoke to an owner of an auto dealership on S. Havana who has experienced homeless people sleeping behind the dealership. Let's be clear, I am not criticizing this activity per se because when the Center closes it has to be empty. Simply put I voted NO to make a statement. We need to provide places for people to sleep at night even if it is a hostel or dormitory arrangement. I understand the noble hope that the provision of counseling will get the homeless back into society. And I am sure it will for some.
