PODICKORY HISTORY

"Podickory Point, New Community, Opens Saturday" read the headline in a news article from the 1960s written by Marjoie P. Crain. Ms. Crain wrote, "A new residential community near Annapolis on the Chesapeake Bay will open officially Saturday. Podickory Point, which incorporates the latest innovations in land planning and design, is located north of the Chesapeake Bay Bridge on the shores of the main bay channel".

The article goes on to say that the community is situated on 49-acres of choice, historic waterfront, and would feature a private yacht club as well as an unusual asset of a small stable. The owner and developer was Theodore J. Martens, who came out from Washington, DC, and found what he was looking for in the Annapolis area and purchased the land in 1959.

Interestingly, at the time, Martens said there were 210 acres available for development to which he intended to add another 150 lots. The article doesn't say where or how, but it is clear that Martens had a vision and admitted that he was more interested in making this place look nice than selling lots.

Martens was a obviously a resident of the community, but there was also another fellow retired Navy officer, Adm. Robert Archer who was their neighbor and a decorated war veteran having been awarded the Navy Cross for extraordinary heroism in action against Japanese forces on May 11, 1945. The article has a picture of Martens and Acher chatting at Martens' home.

Martens set about to create not just any subdivision, but as he said, "to make Podickory something genuinely different, infinitely better than most existing waterfront communities".

The burden describes the promissor's (property owner) duty to perform the promise. The benefit of a real covenant describes the promisee's (other property owner) right to enforce the promise.
