#### **Letter From The CWCA President**

The Bagster

Buy. Fill. Gone. Maybe you have seen the display at your local home improvement store. For right around thirty dollars you too can have a mini-dump-ster to help with your kitchen or bathroom remodel. Perhaps you have some larger items to dispose that just won't fit into your trash can. The Bagster can be a great option. Most neighbors are good at buying, filling, and



removing the Bagster when the job is done. Did you know it costs \$120 to have a Bagster picked up? Some residents don't realize the \$30 needed to purchase a Bagster only buys the bag. Because of this a few neighbors are good at buying and filling, not so good at the "Gone" part.

When it comes to enforcing covenants the CWCA Covenant Control Group (CCG) tends to be understanding when residents require a dumpster or bagster for a specific purpose, such as a remodel, even though Covenant C-10 expressly states "No lot shall be used or maintained as a dumping ground for rubbish". C-10 goes on to say that trash shall be kept in sanitary containers and those containers shall be kept within a building or enclosure. The CWCA has further clarified that proper storage can be behind a fence or in a garage so the container is hidden from view. The CCG understands a dumpster or bagster is too large to be easily hidden from view and so requests that anyone needing a dumpster/bagster please contact CWCA before acquiring the dumpster/bagster with information regarding dumpster/bagster arrival and removal dates (CWCAtalk@gmail.com or 303-904-8218). The CCG is starting to see some residents leaving full bagsters in their driveways or yard for extended periods of time, sometimes many months, with no sign of use. Residents are reminded these containers are considered rubbish by our covenants and either must be removed, stored behind a fence or in the garage. Residents storing bagsters in their front yards will receive a C-10 violation from the CCG unless an arrangement to temporarily store the bagster has been made and the bagster is removed at the agreed upon date. Please help us keep our beautiful neighborhood clean and attractive for all our residents.

#### "Question, Question?"

During the Dumpster Day event this year a survey was passed out to all participants with questions and room for comments. One of the questions was "Would you be interested in Hazardous Waste recycling in the future?" When the results of the survey were tallied it became apparent that a Hazardous Waste option would be very welcomed. One responder wrote "Would pay a fee to have Hazardous Recycling"and another wrote "Thank you. Paint recycling would be great". So with this information we set out to see what could possibly be arranged. Rooney Road Recycling is located at 151 South Rooney Road, Jefferson County. Our family decided to schedule an appointment at www.rooneyroadrecycling.org. for disposal of our own hazardous waste and check in with the associates and ask some questions about possibly having a neighborhood hazardous waste drop-off at Dumpster Day. It was explained that Rooney Road Recycling is designed for individual homeowner drop off only. The recycler does not do community event waste pickup. A homeowner can schedule an at-home pick up for their convenience. Institutions are required to dispose of their hazardous waste elsewhere and this tends to be very costly. We regret to say Dumpster Day will not be able to offer hazardous waste disposal for these reasons.

The Rooney Road Recycling Foundation's mission is to protect our communities and environment by providing a community-based pollution prevention program by serving as a regional recycling resource. The recycling center is the only 501(c) 3 non-profit recycling center in the state to provide subsidized recycling services for hazardous household waste. 


# Foothills Parks and Rec District Says It Will Be Unable To Balance Budget By 2020

Littleton-area resident Diane Suchomel is an avid user of Foothills Parks and Recreation Districts trails — and she can tell the district needs more resources. "When I'm walking through all the parks and trails, I can see the things that need fixing," she said, describing cracked, uneven and unpaved trails. Suchomel was one of about 35 district residents at a meeting April 27 at which Foothills Parks and Recreation District made its case for a mill levy increase it is considering for the November mail-in ballot. The meeting was full of constituents invited by the district to be a part of its "citizens committee" and asking them to drive support if and when the Board of Directors decide officially in July to put the question on the ballot.

"In general, we were hearing pretty much a consensus that people felt like we demonstrated a need and felt like this is something worth pursuing," Ronald Hopp, the district's director, said after the meeting. However, the district may still face an uphill battle convincing voters who previously turned down mill levy increase requests in 2008 and 2014, and will see an increase in property taxes as home values in the area are estimated to go up 22.6 percent this year. "Nobody likes to pay more taxes so people I think are going to be cognizant that it will be a few more dollars out of their pockets," Hopp said. "Hopefully we can demonstrate the need." Hopp presented an overview of the district's operations costs and what has been

done in recent years to cut costs. The district contends that since voters rejected the funding increases, it has cut costs and found ways to increase revenue by 32.5 percent. Still, the district operates with an annual net expense of around \$2.4 million and estimates it will be operating in the red by 2018. with the amount ballooning to more than \$1.5 million by 2020. "We could probably squeak by for the next couple of years, but by 2020 we're going to be unable to balance the budget if the trend continues the way our forecast says," Hopp said. Foothills lists five main funding priorities for the mill levy: maintain parks and open spaces; extending, connecting and maintaining trails; improving water and energy use efficiency be replacing aging systems; making parks are more accessible; and keeping up with minimum wage increases for staff. The majority of Foothills' 93,000 residents — about 95 percent, according to Hopp — pay 7.19 mills, of which 2.001 mills are from a bond issue that expires in 2020. That contributes about 30 percent of the district's \$30.371 million budget, according to the district's website. Non-property tax resources include operating revenue, grants, lottery funds and the selling of assets. The district is already in the midst of major updates to the muchloved Clement Park, a more than \$9 million renovation that includes renovating and replacing restrooms, lighting and an interactive water play area. It is also adding picnic structures continued on page 5

that can be rented for more potential revenue for the park, as well as a place to accommodate food trucks. The district aims to have much of the work done by the end of the summer. It could be easy to see the extensive work at Clement Park as inconsistent with the need for more money, but more than half of the funding for the project came from grant processes with Jefferson County Open Space and Great Outdoors Colorado. Hopp said grant dollars don't pay for hidden needs like aging infrastructure and wage increases. He thinks the district's constituents will still see the need for the mill levy increase. "We know our constituents are smart people," he said. "These are typically grant dollars. What we will need assistance with the mill levy are operating expenses." "We have irrigation systems that are 40 to 50 years old and highly inefficient. They are probably wasting water. That's not glamorous, but it's an important fix to make sure our turf conditions are good and we're not wasting water resources." Informed by surveys conducted by polling firm Public Opinion Strategies, the district is eveing an increase of 2.75 mills with a nine-year sunset. The remaining 5 percent of Foothills' residents are in two other subdistricts and pay a different mill levy, but would be subject to the same 2.75 mill increase. Lori Weigel, a partner with Public Opinion Strategies, at the meeting presented results of the surveys conducted among 300 active voters in the district in early March. Those results were in the district's favor, but, Weigel said, it means more potential momentum for support, not a guarantee. "This is more like 'Is there potential for a citizens group to move forward and come together,' "she said. The district will be taking its presentations to homeowners associations, such as the Council of Homeowners Organizations for Planned Environment, a collection of HOAs in Littleton. Suchomel is vice president of that group and said that while she could not speak on behalf of her fellow members, she said she is very much in support of getting Foothills more funds and will be spreading the word. #### Behind the Badge: Student Cyber Security Safety

It feels like summer just began, but the start of another school year is right around the corner. It's time to purchase school books, pencils and pens, and backpacks. On the list may also be a new computer, laptop, or tablet. As students get back into the swing of doing homework and aiming for high grades, the Sheriff's Office recommends they also take precautions to thwart malware and phishing schemes by practicing safe technology usage. Malicious cyber activity affects students in a variety of ways, ranging from scams to cyber bullying. Fortunately, there are a five simple steps you can take to keep you, your kids, and your devices protected from the latest threats. 1. Keep software up-to-date - Be sure to keep the operating system, browser software, and apps fully updated with patches. Even new machines can have out-of-date software that leaves you at risk. Operating systems and applications are constantly being updated to fix bugs and address security issues. You should use automatic updates to ensure you're using the most secure version of the software that is available. Also, review the privacy settings - when an app is updated, it may change your settings. 2. Malware Protection - Make sure to have antivirus and anti-phishing support installed on all devices (desktops, laptops, tablets, etc.). Set it to update automatically and run virus scans at least once a week. Since malware today is increasingly sophisticated and can avoid detection by antivirus software, also consider installing script-blocking and/ or ad-blocking browser plugins. 3. Practice Safe App Usage - Use trusted apps and only browse trusted websites. Malware is often hidden in apps that trick you into downloading them or in fake websites that lure you in with interesting pictures or stories. 4. Be a Smart Network User - Don't access personal or financial information over unsecured public WiFi networks such as the free WiFi in

coffee shops, bookstores, hotels, and schools, as this data can be easily 'sniffed' (a.k.a viewed) by others. Instead, consider using your smartphone's more secure cellular signal to surf the Web, and if you have other devices, 'tether' them to your phone instead of using an open and unsecure WiFi. 5. Be on Guard for Phishing - Don't open email attachments from untrusted sources. You may be expecting emails from group members or teachers, but use caution when opening any attachments. If you are not expecting an email or it just doesn't look right, don't open it. It could be a phishing attempt. Here's to a safe school year for Jefferson County!
