CONSTITUTION OF THE ASHBOURNE HILLS CIVIC ASSOCIATION, INC  
ARTICLE FOUR

EXECUTIVE BOARD

- Section 1. Only active resident members\* of the Association shall be eligible for nomination to the Executive Board.
- Section 2. The Executive Board shall be composed of the President, Vice-President, Secretary and the Treasurer.
- Section 3. President: The President shall preside over all meetings of the Association and the Executive Board. She/He shall call all meetings of the Association and Executive Board, except as otherwise provided in this Constitution and By-Laws. She/He shall appoint the chairperson of all committees. She/He shall execute all agreements approved by the Association or the Executive Board. She/He shall be responsible for ensuring that the budget is prepared and submission of the budget as provided in the By-laws. She/He shall be one of the officers qualified to countersign checks for the payment of money.
- Section 4. Vice-President: The Vice-President shall perform the duties of the President in his/her absence or disability or when so requested by the President. In the event of the death, resignation, or removal from the office of the President shall become President. She/He will automatically succeed the President to office upon the completion of the President's term of office. She/He can be one of the officers qualified to countersign checks for the payment of money.
- Section 5. Secretary: The Secretary shall prepare and keep such books of record of the business of the Association as the Executive Board or the laws of the state of Delaware may require. The Secretary shall carry on the correspondence of the Association at the direction of the President or the Executive Board.
- Section 6. Treasurer: The Treasurer shall keep full and accurate accounts of the financial transaction, receipts, and disbursements of the Association, in the books to the Association. She/He shall deposit the funds and other valuable effects of the Association in such depository or depositories as may be designated by the Executive Board. She/He shall be one of the officers qualified to countersign checks for the payment of money.

\*Active Resident Members are those households that have paid their 2018 Dues.
