Its Going to Snow... and JeffCo Road and Bridge will be on top of it!

Jefferson County's Road & Bridge Division is currently responsible for snow removal on 2,900 lane miles of paved roads and 700 lane miles of gravel roads in the unincorporated areas of the County. One lane mile is a 10 foot wide section of road one mile long. State highways, private roads and newly constructed roads that have not been accepted by formal resolution of the Board of County Commissioners are not included.

Forecasting and Preparations:

The Road and Bridge Division is on a twenty-four hour, early-warning alert system. Supervisors utilize local, national, and customized weather forecasts and databases in order to anticipate and be prepared for the intensity of storm forecasted. Equipment is made ready for sanding and plowing during normal working

Each equipment operator is assigned a specific route for snow removal and sanding. Assignment of roads to a route is determined by area supervisors based on priority of the road as defined below and for the most efficient utilization of equipment. Snow Removal Procedures:

Plowing and sanding operations will take place in four phases during a storm. The order in which streets are plowed in each phase is based on the following definitions of priority:

- Priority 1 Main arterial streets that provide for high traffic volumes.
- Priority 2 Major subdivision collectors, school zones and school bus routes.
- Priority 3 Residential or other local roads that carry moderate to low traffic volumes.
- Priority 4 Cul-de-sacs or other dead-end roads carrying very low traffic volumes.





Recreational Vehicle Parking by Jeffco Sheriff Dept

The parking ordinance considers RVs and trailers to be the same as a car or passenger truck when parked on the street, with the exception that they may not be parked there longer than 28 days in a year. A recreational vehicle is any vehicle designed to provide temporary living quarters. 'Trailer' does indeed include boats on a trailer as well as any other item such as cars, trash, and trees. The ordinance applies only to public roadways in residential areas in unincorporated Jefferson County. For deputies to respond to a complaint of an illegally parked vehicle the sheriff's office must simply receive notification that it has been parked longer than 28 days total in a year. Curbside parking of recreational vehicles and trailers has posed a problem for some Jefferson County neighborhoods in the last several months. The sheriff's office is responsible for enforcing the parking ordinance. The ordinance does not prohibit the parking of recreational vehicles (RVs) and trailers outright. It simply limits the amount of time such vehicles may be legally parked on the street to 28 days in a years time. County ordinance prohibits the parking of any vehicle for sale on a public roadway in a residential area. A major motor vehicle is any vehicle wider than 8 feet or longer than 25 feet or a truck or semi-trailer, regardless of size. County ordinance prohibits the parking of a major motor vehicle on an unincorporated Jefferson County public roadway in a residential area except for loading and unloading, and other immediate active use.

Wood Burning Standards

All new wood-burning stoves and fireplaces installed in Jefferson County must meet stringent Environmental Protection Agency (EPA) emission standards. During high pollution days (red days), no wood-burning is allowed below 7,000 feet elevation, except by using EPA Phase III stoves, approved pellet stoves or approved masonry heaters. Complaints about wood-burning during high pollution days should be directed to your city officials (usually the zoning department). CrazyCrayons.com is a site associated with a family-run business that sorts and melts down old crayons, then ships new ones to children's hospitals. TerraCycle.com helps turn old toothpaste tubes, toothbrushes, empty floss containers, and such leftovers into new plastic products. ItsFromThe Sole.org and Soles4Souls.org both accept donated shoes and distribute them to people in need. 
