Speed Bumps

Many residents in Gulf Meadows Civic Club Sections 2, 3, and 4 have been inquiring about installing speed bumps on the streets in our community because of the loud, frequent car racing after midnight and the danger racing can do in a community.

In order to get speed bumps, we must show that the majority of residents in this community want them by signing a petition. We need volunteers to work assigned streets in this community to get signatures. To volunteer, call (713) 991-2673 and leave a message. Leave your name and phone number and I will get right back with you to give you the paperwork that needs signing. The streets are Lettie, Coastway, Gulf Tree, Gulf Spring, Gulfwood, Springtime, Garden Parks, Misty Vale, Ballantine, Gulf Valley, Wingtip, Arendale, and Gulfdale.

The city of Houston is still installing speed humps in our city, and it was recently sited last week. Note: Speed humps are built to accommodate emergency vehicles now and speed bumps will be placed in the most dangerous zones in the neighborhood to stop racing.

I cannot do this project by myself, but if you want speed humps, please call to volunteer. Also, anytime you hear racing on your street or any other problem dealing with speed and affecting the safety of residents please try to keep records (date, time and/or what happened). That would be most helpful in showing our need for speed bumps.

As always, we are working to keep Gulf Meadows a place where all love calling it home.

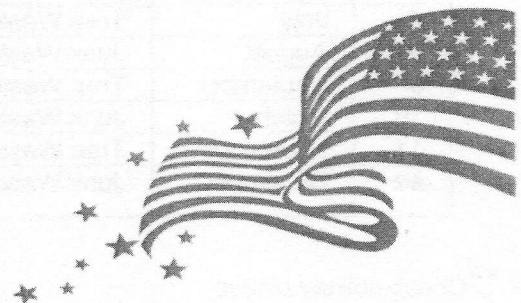
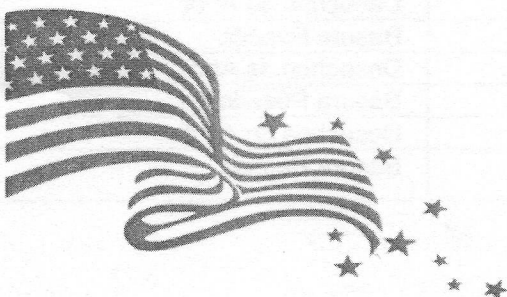

The city has a sign code that governs unlawfully posted signs and by code designates those authorized to remove unlawfully posted signs. Let it be clear we are not to be confrontational in any derogatory way. I ask that if we notice any unlawfully displayed signs that a call be placed to #311 and report the violation rather than create an unpleasant situation for you and another resident. 5. **Time:** 9:00 am till 3:00 pm.-- free
