Dumpster Day for 2020 Mark your calendars for Saturday, June 20th. All residents that are current with



Update on Foothills District Produced Summer Events

We are extremely disappointed to announce that due to the current COVID-19 pandemic and gathering limitations set by the State of Colorado, Foothills Park & Recreation District has no choice but to cancel the following events produced by the District: the Red, White & You patriotic celebration and the full run of Shakespeare in Clement Park. Additionally, we will not start up the free Concerts in Clement Park until after July 16, at which time we will re-evaluate the situation. Based on the size of these events, the planning time that it takes to implement them, and the fact that current State of Colorado health orders limit gatherings to no more than 10 people for the foreseeable future, we do not believe that large-scale events will be allowed to be held for quite some time. We realize that these cancellations will sadden many who look forward to our summer events each year, but protecting the health and safety of our families, friends, neighbors, employees and volunteers is our top priority. A House of a Different Color-

Having only been a resident of our community for a year now, sometimes things can be a little confusing when it comes to figuring out what the "rules" are. In talking to several neighbors, the only thing I've learned so far is that, in years past, the CWCA has had certain members of the Board of Directors whose sole purpose in life was to harass the homeowners and enforce "rules" that did not seem to actually exist.

Recently, my husband and I decided it was time to get our home exterior updated with a new paint job. Being a nice person who cares what my neighbors think, I asked my immediate neighbors for their opinions on some paint colors I was considering. Nothing too crazy- maybe a pretty blue with white trim. Heck, there are other houses in the neighborhood with similar colors, so it didn't seem to be much of an issue. Several neighbors, however, informed me that I would have to "check with the CWCA" and "get the paint color approved, because if they don't like it you might have to repaint your house. They made someone do that!" This seemed to be a common theme among most of the people I talked to- with many believing that the "covenants" explicitly stated that the neighborhood allowed "only earth tones".

I was pretty confused by this. All things considered, there are houses down my street that are painted dark greens, blues, and even pink. Hardly what I would consider to be "earth tones". I'm pretty sure there's a house in our community that's purple, too. I contacted Natasha McCombs, CWCA Secretary and she wrote me that not only are there *no* requirements to get house paint colors approved by the CWCA, there are also NO covenants specifying any particular color scheme or "allowable colors" to paint our houses. In fact, as far as the story about someone in the neighborhood years ago who "had to repaint their home",

As for me... my house will be a lovely "Blue Jasmine" with white trim, and I'm pretty excited about it. And no, I didn't need anyone's permission. I can assure you; the CWCA is not an HOA with some cranky old man as the President whose sole purpose in life is to walk the streets of Columbine West just looking for something to write you a stern letter about. Perhaps if we took the time to get the know the association instead of putting up walls, hating on them at every chance, and assuming a negative attitude toward that which we do not fully understand... then maybe our neighborhood would start to see more positive changes and less animosity toward the CWCA.

The CWCAtalk@gmail.com received another request from a neighbor concerning chickens. "Can we feed Ourselves? I notice a lot of gardens being planted, we are thinking long term of feeding our families without an income we are doing the best we can. It would be so helpful to be able to have chickens. For the eggs and for the meat. This pandemic is unprecedented and we who can help ourselves can with our little gardens and chickens. Why not bend the rules for those who want to try and survive. We can put a limit on the amount of people who live in the home. Paint the chicken coop. So many feet from the neighbors house. Just something to help. Please. We want to feed our families!"

From CWCA: We have a covenant for poultry and livestock. For those unfamiliar it goes like this:

C-9 LIVESTOCK AND POULTRY

No animals, livestock, or poultry of any kind shall be raised, bred, or kept on any lot, except that dogs, cats, or other household pets may be kept provided that they are not kept, bred, or maintained for any commercial purpose.

Honestly, I have answered many questions like this regarding the covenant ever since Jefferson county decided to allow chickens, in a limited way, around five years ago and I am tired of repeating myself. This particular covenant <u>clearly forbids</u> poultry in Columbine West including chickens, ducks, geese, or any other bird one would find on a farm. If you live in Columbine West this covenant and the other (9) came with the purchase of your property. All homeowners are legally obliged to follow them and CWCA will enforce covenants with legal action if necessary. To be clear, our covenants have precedence when there is a conflict with Jefferson County ordinance as in this case. CWCA can not "bend the rules" as we have no authority to do so. Our message is simple, if you are thinking of acquiring chickens, DON'T, and if you currently have them you must DISPOSE OF THEM. They are not allowed in Columbine West.

Hot Baths May Aid Your Health

Want to relax during these days of tension and worry about COVID-19? A long, hot bath can relieve your stress—and maybe help your heart.

The Web MD website reports that a study of more than 30,000 adults in Japan found that a nice, steamy soak may reduce one's incidence of high blood pressure and stroke. "We found that frequent tub bathing was significantly associated with a lower risk of hypertension, suggesting that a beneficial effect of tub bathing on risk of [heart disease] may in part be due to a reduced risk of developing hypertension," said the study's lead scientist at Osaka University.

After accounting for other factors, the researchers found that taking a daily hot bath was associated with a 28% lower risk of heart disease and a 26% lower risk of stroke, compared with subjects who bathed only once or twice a week.

So relax in the tub, and try to take your mind off your worries. It's good for your body and soul.

Thousands Volunteer For Space Missions

Feel like getting off the world for a while? You've got company. As the *U.S. News & World Report* states, some 12,000 people have applied to become astronauts following a call from NASA for volunteers. It's the second - largest group of would-be spacefarers in the agency's history.

The hopefuls come from all 50 states, as well as the District of Columbia and four U.S. territories. Those selected will probably travel to the International Space Station and pave the way for exploration of the moon and Mars.

The previous call for recruits drew a record 18,300 candidates, of which 12 were ultimately chosen. This time around NASA tightened its qualifications, requiring a master's degree in science, technology, engineering, or math. The current active astronaut corps numbers 48.
