

#### **Greetings from Mario**

On Saturday, June 27, 2020, I had the privilege of participating in the First Annual Deco PRIDE RIDE Parade. Before going any further, I want to state that the event was not a sponsored JNA activity, and I respect everyone's personal beliefs. The purpose of the article is not to push an agenda but to showcase what our community represents.



PRIDE commemorates the Stonewall riots, which occurred in 1969. During the month of June, PRIDE events are held to recognize the positive impact that the LGBTQ community has in our cities and neighborhoods and to bring attention to the prejudice that is still part of our society.



During a conversation with Camille Rodriguez-Brigant, owner of MOTIF Boutique Brokerage, I mentioned I was going to sit in my front yard on Saturday June 27<sup>th</sup> to celebrate PRIDE after our city celebration was cancelled. Recognizing the importance of PRIDE especially now when the community needed a morale boost, we decided something

bigger was needed.

Such was born the First Annual Deco PRIDE RIDE Parade. On Saturday over 25 vehicles drove through our neighborhood, decorated in PRIDE colors, playing music, and waving to our neighbors. With hard work, the event raised over \$1,100 for the Fiesta Youth Organization, located on Donaldson. The organization supports LGBTQ youth through education, peer-support, advocacy, and friendship.



The event was a great success, not only for the short amount of time that we had to plan the event (less than a week), but what we saw as we drove through our community.

Over 300 door hangers were placed on the parade route a day before in hopes that families would come out and

enjoy the festivities. As we started the parade, we were

nervous, as we did not know what to expect. To our surprise our JNA community did not disappoint.

Families had set up tables and chairs in their front yards, were playing music, waving signs and PRIDE flags. They had smiles on their faces and you could feel and see the love in their hearts. I was overwhelmed by the support.



As we continued to drive on Donaldson, W. Gramercy, W. Kings Hwy, and around Woodlawn Lake, we could see that families were waiting for us to drive by. What a feeling!

What does this tell me about our JNA neighborhood? We are a community that is accepting, loving, and a place that we can truly call home. This is not just a neighborhood of houses, but a community that is willing to see passed labels and politics and see each other for who we are-JNA Neighbors!

This I hope, is the beginning of new adventures in our neighborhood.

Believe it or not, election officers for the next fiscal year is fast approaching.


Our by-laws state that a nominating committee will be formed in June, their report given in July, and election in August.

#### **Ballot By Mail Rules**

On May 27, 2020, the Texas Supreme Court determined that the lack of immunity alone is not a "disability" for purposes of voting by mail. However, the court also stated that a voter can take into consideration aspects of their own health and health history when determining whether in-person voting will cause a likelihood of injury due to a physical condition.

To request a ballot by mail based on a disability, an eligible voter can check the box for disability on the request form and submit to the Bexar County Elections Department which will then provide a ballot by mail.

# Fighting the Rise of COVID-19

Many new COVID-19 cases have been reported in San Antonio. To all those who wear a mask, wash your hands, and stay home as much as possible: thank you.

As a community, we need to continue wearing masks, giving people space, and staying home when possible.

This goes for young people, too. A large part of our new cases are people between 20 and 29 years old.

While most of them will recover, if they are around older people they may put them at risk. Older people are more likely to suffer the worst consequences, such as hospitalization,

respiratory problems, heart problems, and even death.

At City Hall, I continue to push for the City to use every tool at our disposal to stop the spread of the virus. But even all the City's resources can't stop the virus without the community taking safety precautions.

Additionally, City Manager **Erik Walsh** announced the following changes to City-owned park properties:

- Gatherings of more than 100 will be prohibited in any city park or plaza.
- ✓ Pools and splash pads will not reopen as previously planned.

#### News from County Commissioner Pct. 2 Justin Rodriguez



Judge Nelson Wolff issued Executive Order NW-11 in response to the increase in COVID-19 cases and to update with limiting elective surgeries in accordance with Governor Greg Abbott's recent order.

Any person over the age of 10 will be required to wear a face covering over their nose and mouth when in a public place where it is difficult to maintain social distancing of 6 feet or more.

All commercial entities in Bexar County providing goods or services directly to the public must require that employees and visitors wear face coverings.

Businesses may also implement other measures designed to control and reduce COVID-19 transmission such as temperature

checks or health screenings.

Commercial entities must develop a health plan which includes the use of face coverings and post it to provide notice to employees and visitors of the requirements. Failure to develop and post a Health and Safety Policy are subject to a \$1,000 fine for each violation.

Face coverings are not a replacement for social distancing, frequent hand washing, and selfisolation when sick.

Please do **not** purchase or wear medical-grade masks or N-95 respirators as they are a needed medical resource for health care workers and first responders.

#### Is It Safe to Go Out to Eat?

Hungry for interaction after a season of quarantine, many are heading into reopened restaurants and bars, eager to sit down for a meal they didn't cook, at someplace other than home.

Yet as coronavirus cases climb now in nearly half of all states, and crowds at some eateries reflect pre-pandemic levels, some wonder: Is COVID on the menu?

According to the FDA,

the coronavirus does n't appear to spread through food, the way some viruses and bacteria can.

Instead, COVID germs travel through respiratory droplets, which means you could get sick if an infected

person coughs or sneezes near you. Even just being around someone speaking makes you more likely to get the virus.

So just how safe is that table inside a restaurant?

Restaurants are scrambling to recover after May sales plummeted to more than 40% below normal expectations for the month.

Yet just a week or 2 after states allowed eateries to resume indoor dining, a number of restaurants and bars are shutting their doors or suspending services once again.

The CDC ranks the risk of COVID exposure and spread in restaurants from lowest to highest risk:

- ✓ Lowest risk: No onsite dining. Food must be delivered or picked up and carried off site.
- ✓ **Highest risk:** On-site dining with no changes in seating.

When you're done with your meal, and when you get home, wash your hands with soap and water for 20 seconds, or use hand sanitizer that contains at least 60% alcohol.

#### **Message from our Vice President**

What makes our Jefferson Neighborhood unique?

One thing is that there is no main street running through it.

Other neighborhoods such Monte Vista. Beacon Hill. Alta Vista, Five Points, and Tobin Hill have main thoroughfares such as Blanco Rd., McCullough Ave., Fredericksburg Rd., San Pedro Ave., and Main Ave. running through them.

These main thoroughfares bring retail establishments such as stores, restaurants, gas stations, and even into these bars neighborhoods. Most of these neighborhoods have sidewalks as well as bus routes that enable residents to have an option to walk or ride to these businesses.

The Jefferson Neighborhood has residential streets running through it with Fredericksburg Rd. or Bandera Rd. as the closest main thoroughfares.

Donaldson Ave., Babcock Rd., Wilson Blvd., Woodlawn Ave., and St. Cloud connect us with the main thoroughfares.

Sidewalks here are limited or non-existent. When this neighborhood was established in the 1930s and 1940s, a new concept was created:

A neighborhood shopping center!

Jefferson Village was built in 1948 to give our residents a place to buy groceries, clothes, school supplies, etc.

There was a beauty salon, drug store, grocery store, dress shop, record shop, and even a shoe repair.

The Village is on Donaldson not far from Jefferson High School and places of worship.

Across the street were a hobby shop, gas station, and doctor's offices.

The aim of this shopping center was to provide these nearby services to residents who could walk to them.

Now, as our neighborhood has evolved, most of us drive to retail establishments and restaurants miles away.

Jefferson Village has changed, too, as their retail base is much different now. We have Dollar General and Vee's as the main tenants. There are two event centers and a couple of other businesses.

Across the street are two restaurants, a flower shop, and a bodega.

The hobby shop has managed to stay in business all these years.

How can we revitalize this area? Some suggestions have been offered over the years but nothing has happened.

The wants and needs of our residents must be considered.

Two neighborhood plans exist which describe retail businesses that are a good fit for this area.

We can always add family-friendly businesses to the lists.

Let our board know your thoughts on this issue.
