Dutch Creek Drainage Improvements at Coal Mine Ave

Project Background: The crossing of Dutch Creek under Coal Mine Avenue is severely undersized for large storm events resulting in overtopping of Coal Mine Avenue. In addition, the existing culverts are near the end of their lifespan and need to be replaced. In partnership with Mile High Flood District (MHFD), Jefferson County worked with Icon Engineering to improve capacity and stabilize the channel of Dutch Creek.

Project Scope: The project highlights consist of the following improvements:

- A three cell 14-foot by 6-foot box culvert will be constructed to carry the flows of Dutch Creek
- The channel of Dutch Creek will be realigned
- Sculpted concrete drop structures and boulder walls will be installed upstream and downstream of the culvert
- A portion of the Foothills Park and Recreation District concrete trail to the north of Coal Mine Avenue will be realigned
- Landscaping will be installed along the new creek alignment

Project Update (as of December 16, 2020): The general contractor, Edge Contracting Inc. (Edge), will begin setting up traffic control and preparing to start construction over the last few weeks of December. Utility relocations will continue through the end of December. Construction is anticipated to begin January 4. Coal Mine Avenue will be limited to one lane of traffic in each direction through the project site during construction. Traffic delays are anticipated, and an alternative route is advised.



inside of the heart. At this point, I was just excited someone had acted on my post. I had no clue how many letters I'd end up receiving.

Up until Christmas Eve, there was hardly a day that I didn't receive at least one letter. Over the course of December, I received and replied to around 160 letters total. On my busiest week, I dropped 44 letters at the post office in just two

days. With every letter I sent, I remembered how exciting it was getting mail as a kid, let alone the idea of getting a letter from Santahimself! I just hoped that each one of these children would feel the same excitement and joy when receiving their letters back. Each of these responses included a handwritten letter, a coloring page, and a "Nice List" certificate. I used envelopes with a North Pole Air Mail sticker, as well as a Santa Claus return address label, for extra authenticity. I'm currently working from home, so I often got to see kids show up and was able to hear them giggling in excitement as they dropped of their letters. It brought me so much joy to just sit and listen.

As you can imagine, there were some letters that were very amusing. The one that stuck out the most to me read: "If you need to use the bathroom while you are here, that is OK, just remember to use the Poo-Pourri." I was also told through a message that after dropping off her letter, a girl said: "I know an elf didn't make that mailbox because there isn't enough glitter on it", so

Many of the letters requested a gift for mom, as well. Kids must think most moms want a winning lotto ticket! Quite a few of the writers asked for gifts not only for themselves, but also others. Some of the most heartwarming requests were: "I would like some animal things to give to the animals that don't have a home", and "I also don't want to just think of myself so I was wondering if I could have some money? I really want to take

my little sister on a girls date to show her how much she means to me, so maybe \$20". I even had a letter ask "Santa, does anyone ever ask you for what you want for Christmas? And if not, what would you like?" It was really refreshing to see so many children thinking of others. I shared a lot of these letters with family and friends as I read them; the letters brought so much happiness to everyone, including myself.

The response to the mailbox was incredible, and the outpouring of generosity from this community was humbling. I had people drop off anywhere from a few extra stamps to pages of stamps, cash donations to go towards materials and postage, even offerings of extra envelopes. Many people, including family, friends, and even strangers, offered to help write responses if I ever needed extra help or got overwhelmed. It was truly amazing to see how many people were willing to help in so many different ways. I just want to thank everyone for their kindness and donations, you really helped be a part of something so special.

For me, the best part was getting to see and hear how excited continued on page 4

Asbestos, What You May Need To Know

If you are planning to demolish areas within your Columbine West home you should indeed have the area materials tested, especially because the age of the home has NO bearing whatsoever on whether there's asbestos present in the popcorn ceiling, or anything else. Contrary to what most people think, asbestos is legal today, and has been except for two years (1989-1991 timeframe) when it was banned outright, then that was overturned by the Federal Court of Appeals. Even a home built during that narrow window could have had older materials used during construction (items that were already in the supply chain and sitting in a warehouse), or newer materials installed subsequently, that do contain asbestos. Also important to know is that asbestos itself doesn't pose any danger just because it's present in the home, it only becomes a hazard if/when it's made friable, which occurs when it's disturbed by drilling, sawing, burning, etc. These activities cause the breaking off of microscopic particles of asbestos, which then float suspended in the air and thus can get inhaled and then lodge themselves in our lungs. Even a little of that won't kill you. It's a lot of this kind of exposure over time that can result in you developing mesothelioma, which is incurable and that's why it's dangerous. Asbestos is a naturally occurring mineral that's in the ground and is regularly mined for use in many industries (automotive brake pads, roofing, and much more)...it's STILL legal for use in many products, because depending on the application, there's often few or zero alternate materials that yield equivalent performance. So the key is to keep people from creating FRIABLE asbestos. Which is why our statutes dictate that we test before demoing areas of wallboard, certain types of flooring, drywall texture, popcorn ceilings, etc. Testing will tell you whether the area should be remediated by a licensed pro who can ensure it does NOT become friable. It's rather uncommon to find asbestos lurking in modern buildings, but it IS still legal, has not been totally banned, and thus it's wise to have an area that's to be demolished TESTED (by a licensed asbestos testing firm) for the presence of asbestos before it's disturbed. If the test comes back positive, then proper remediation by a licensed Asbestos Removal con-

tractor is required. By law. For everyone's safety. Hope this is helpful!

Kiwanis Club of Columbine: Staying Home is an Experience

I have found myself delving into my psyche, digging into memories for many different reasons. And because of that I have found that I have let myself wonder about my life, where it has taken me and where it might be going, hopefully, when the virus rascal has been isolated from us all. One of my questions was where am I supposed to be? There are books to write, but I could care less some days. At times, I isolate myself from even myself. My vulnerability gene plays havoc with me. I went for a period where I gave up

reading. Hard to believe, I know. Me, a writer, not reading. This change gave me a laudable 5-star ranking from Netflix, Prime TV, CNN and MSNBC. So as life does, depression came knocking. And one day, running out of milk was the last straw. Masking up, I found myself swooping through the doors of King Soopers. Quick stop. Heading back to the car, I noticed a piece of shiny metal. I stopped and picked it up off the concrete. I was startled when I saw what it said. "Perhaps this is the moment for which you have been created."

It was as if it was there just for me. Just waiting to let me know that somehow things would be better and that I had to make them better for me and for everyone I knew. I could do things from my own house without seeing anyone in person. I began to feel better. I baked blueberry muffins and took them to a neighbor. They liked them so much, I did it again. I began to call, text and email people literally all over the world. I accelerated my letters to my baby daughter, who lives in France, and to a dear friend, Sister Hilda Tucker, a missionary in Nigeria.
