

A summer like no other

Regrettably, our neighborhood pool will not open this season.

On May 27, St. Louis County shared its requirements for public pools to operate legally during the pandemic (our pool is considered a public pool). The rules included requiring an attendant at the pool at all times to ensure cleaning and social distancing guidelines were being observed and masks were worn by those not in the water. We would also be required to monitor and test the chemicals in the water every two hours while open and prior to opening each day.

The Danbury Pool Committee and Danbury Trustees deemed these and the other requirements too difficult to enforce. Regardless of our desire and enthusiasm to open the pool, the liability

present in this circumstance is simply too great for our neighborhood to assume. This situation does give us an opportunity to re-surface the pool and/ or consider improvements to the lake with this season's pool fund. More on that to come.

Looking to give the lake a makeover

Our lake has a purpose: to capture rainwater (aka, stormwater runoff) and store it, at least temporarily. Runoff accumulates pollutants from streets, roof-tops and yards, eventually reaching the lake where the pollutants settle. The lake suffers negative results of the contaminants: poorer water quality, reduced aesthetics, and decreased habitat value. Unfortunately, these problems can be costly to remedy.

Recently, an official at the Missouri Department of Natural Resources provided some suggestions on how to improve the quality of our lake. The options are being evaluated and will be discussed when homeowners and trustees are able to meet again/when COVID-19 restrictions are lifted.
