## **SHERIFF'S REPORT FOR PRAIRIE TOWNSHIP**



The Sheriff's department averages over 600 calls in two weeks. These calls are mostly for suspicious persons and vehicle traffic. Theft issues dealing with local businesses are also being reported. The Sheriffs did apprehend a minor breaking into cars in Lincoln Village North. Please lock your cars and remove anything of value. Even while driving do not have valuables in plain sight. They would also like to remind everyone to keep your garage doors closed.

Deputy Hamilton would like to remind residents to email the Sheriff's Department complaint system online for any junk vehicle they need to tag. Also, they are towing for any expired tags after 48 hours of being left on the roadway. As a reminder, the Sheriff's Department deals only with vehicles on a roadway not in a yard.

## **FRANKLIN COUNTY SHERIFF - IDENTITY THEFT**

Identity Fraud Laws, links to the three major Credit Bureaus, Federal Trade Commission, Attorney General's Identity Theft Verification Passport and a map to The Franklin County's Passport Issue site, as well as useful statistics just released ranking Ohio 4th out of the 49 largest Major Metropolitan Cities, dealing with Fraud related complaints, and 34th out of 49 dealing with Identity Theft related complaints.

This report also rates Ohio 24th and 26th out of all 50 states in Fraud and Identity Theft complaints by victims, Columbus , being the #1 City in Ohio , for Fraud complaints and # 2 Cities, for Identity Theft, with 10,120 reported complaints and losses totaling over \$12,765,255.
