HOLIDAY SAFETY WHILE TRAVELING

The two most common travel times are during the summer or winter holidays when families can spend some time away from the home together. Of course the point of any vacations to have fun, relax and get away from it all, but it is important to take a few safety precautions to make sure your trip and return home is trouble free.

- 1. Make sure that a friend or trusted neighbor knows where you are going and how long you will be gone. That way if you are not back when you should be, they will have an idea that something may be wrong. Give them an emergency contact number in case they need to reach you.
- 2. Arrange for someone to drop by your home now and then to check on it, and give that person a key so they can get inside.
- 3. Have newspapers and mail delivery service temporarily stopped while you are away. This is done to prevent your home from looking vacated. A criminal who passes by your house and notices a full mailbox or several days worth of papers on the lawn will realize that you are not around, and may view it as an opportunity to break in.
- 4. Purchase timers for your lights and television. These will turn on at a pre-determined time each night so someone who is stalking your home will believe somebody is home. You can also turn on a radio talk station to emulate the sounds of a conversation going on in case a criminal comes close enough to listen.
- 5. Make sure the ringer on your phone and answering machine are turned off. A phone that is never answered will arouse suspicion, and may cause the law breaker to perform a more thorough inspection.
