

## **Changes to Trash Pickup**

Our trash collection drivers' schedule changed earlier this year. They no longer pick up our neighborhood's trash first on their route each Monday, but instead arrive later in the day now. It is VERY IMPORTANT that all of your trash be BAGGED before it's put into your trash bin. We have many windy days in Ridgepoint, and if your trash is blowing around the neighborhood because it wasn't bagged, we'll ask you to pick it up. Also, please remember to put your trash cans away (out of sight) except for Monday when trash is being picked up by Waste Management.

### Yard Reminders

Please remember that well-groomed yards make our neighborhood look more attractive and show pride in our community! Please trim your grass frequently. Also, please trim back bushes, shrubs and trees that extend over the sidewalk and remove weeds from your land-scaping. When we all do our part, Ridgepoint looks great!

## **Open Space Maintenance**

Please do NOT throw bottles, pallets, clipped grass or other trash into the open space. This is NOT a dump. If items are found behind your house in the open space, we will ask you to pick them up and dispose of them properly. Also, the open space is not your dog's yard. If your dog poops in the open space, please pick it up! We really prefer that you keep your pets out of the open space at all times. There are many areas that are in various stages of erosion and any kind of traffic on those areas just makes it worse. We are trying to find a solution for the erosion problems, but because of the poor quality of the soil (dug out from basements and left there when the homes were being constructed) and the steep slope, it's a difficult and expensive task. There are several great improvements to the website Nextdoor to make you aware of. Currently, we have over half of our Ridgepoint residents connected through this great network. The website was created to give neighbors a way to network with each other however, Nextdoor is much more than a social network. This is a place to share safety information, offer or ask for services (baby sitting, lawn mowing, dog walking) and keep up to date on neighborhood events such as National Night Out and Caroling. Your information can only be viewed by other neighbors, and you decide how much (or how little) to enter when you're setting up your profile. The Board has started using Nextdoor as a way to "get the word out" about neighborhood issues. Additionally, the Jefferson County

You can expect to receive local crime and safety updates from the Jefferson County Sheriff's Office and please be assured that our neighborhood's Nextdoor remains private. The Sheriff's Office will not be able to see any of the content on our neighborhood site except for the direct replies to their posts.

Many thanks to Tami and Barry Winchell! Tami is a member of the Architectural Review Committee (ARC). She also weeds the front entrance on a regular basis, plants annuals and perennials to add color, and maintains the area all summer long, with the help of Mary Jo Davidson and Mimi Lowrey. She spent an entire day earlier this year trimming back dead plant foliage and picking up trash all over our open space. Several bags later, we have Tami to thank for a nicely maintained common area. She also works with Roscoe Davidson and the lawn maintenance crew to ensure that the proper maintenance is being provided weekly as well as on an as-needed basis for special projects. Barry works with Roscoe Davidson on the sprinkler system maintenance and schedule. He was helpful in finding a reliable, affordable company to hire to maintain and repair our sprinkler system, and continues to work with them to meet our watering needs. He was also instrumental in getting the damage from the car in the new sod area repaired quickly in late May. Barry and Tami are also working with several homeowners to plant native bushes and shrubs in our open space and water them for the first two years until they're established. We'll then be able to assess which plants will work to help prevent erosion on our hillsides and do more planting!

#### DOG WASTE and LEASH LAW

We continue to have problems with dog owners not picking up after their pets in the open space and throughout the neighborhood. Please be a responsible and courteous dog-



owner and pick-up after your pet. Jefferson County has a leash law and it requires that your animal must be leashed AT ALL TIMES if it is outside the boundary of your property. If you observe an animal off leash, whether it is with an owner or not, please call **Jefferson County Animal Control at 303-277-0211.** This is NOT an HOA rule; it's county law and the county will enforce it.



#### What are Permissible Fireworks?

Cylindrical or cone fountains, wheels and ground spinners, illuminating torches and colored fire, dipped sticks and sparklers, toy propellant or toy smoke devices, trick noise makers and snake or glow worms are all permissible

#### What are Illegal Fireworks?

Any devices or components that, when used or ignited, project or disburse any metal, glass, or brittle plastic fragments. Cherry bombs, roman candles, firecrackers, bottle rockets, shells and rockets, M-80s and M-100s, and helicopters are all examples of illegal fireworks.

A good rule of thumb: anything that explodes or leaves the ground is most likely illegal in Colorado.

REMINDER: 3rd Quarter dues were due on the 1st and must be received by the last day of the of the June to avoid LATE FEES!
