#### Breckenridge Brewery Makes Big Strides Toward Completing its 'Destination Brewery'

As giant metal tanks reach toward the sky inside the skeletal frame of a barn-like production facility in Littleton, Colorado is getting closer to having a new destination brewery that its owners believe will bring in visitors from the Denver area and from across the country. With its valuable brewing hardware in place, officials can now concentrate on completing the buildings around it and getting it ready to receive its first visitors by April. In a state with roughly 250 breweries, the opening of a new brewhouse is not always considered news. But Breckenridge's \$20 million facility will be one of the largest and most audacious brewery properties in the state, one that is being constructed with room for several tour buses to pull into the property at once and with the idea that offering visitors a place where they can tromp around a hop garden or dine in a 270-seat restaurant adjacent to a concert area will make them want to come to the area to see the attraction."I don't think there is anything like this in Colorado," said Todd Thibault, the brewery's director of marketing. "I really think this is going to be one of the coolest breweries in Colorado, if not the country. It can be a destination brewery." The 15,000-pound fermentation tanks that were lifted through the roof area and set into place in the production facility Thursday will allow Breckenridge, which already is the sixth-largest craft brewery in Colorado and 40th-largest such brewery in America, to grow significantly.



#### Student Based Budgeting

Jeffco Public Schools 'Chalk Talk' November 10, 2014

As I have been visiting schools and attending meetings in the community, people are asking questions about Jeffco's new approach to funding our schools called Student Based Budgeting (SBB). This may be a new phrase in our community, but it is not a new school funding concept. SBB has been used by school districts since 2000, in fact the idea was considered in Jeffco several years ago. It is currently used by Denver Public Schools, Cherry Creek, Douglas County, Adams 12, Poudre and several other Colorado districts. The time has come for SBB to be implemented in our schools. It's an opportunity for principals to have more control over how money is spent to further student achievement in their schools. Previously, principals were held accountable for achievement results, but they had little control over the resources they needed to get those results. Funding decisions were made at the central level based on staffing formulas and school-specific programs. With SBB, schools will be funded per student, and the amount of funding attached to each child will vary based on his or her needs. Jeffco principals are currently receiving training and guidance about SBB and how to work with their school communities to determine spending priorities. Over the next several months you will be hearing more about Student Based Budgeting as we develop additional informational resources. 
#### **News From Open Arms Food Bank**

Open Arms Food Bank is your local community food pantry, located at 6500 W. Coal Mine Ave., Littleton, CO 80123. We are located across the parking lot behind Goodwill, and behind the McDonalds; the food bank is in the back (South side) of the Church for All Nations building.

We are reaching out to the community because there are several volunteer positions open. We have food pick up routes on various days at local stores. A typical pick up involves about 1 hour of your time and use of your car. We also have volunteer positions available on Tuesday, our distribution day, as well as positions for maintaining and organizing our pantry shelves. We have volunteers that live in your neighborhood who have helped us for years. If your high school student needs to complete volunteer hours for their graduation requirements, we can work with them. Rather than succumb to these impulses, just notice them and ask what might be triggering them, then try an alternative to stuffing food down your throat to suppress them.

To beat the blues there are several strategies that may help. Most importantly stick to (or create) a daily exercise routine. Becoming lax in exercise through the holidays will not serve you well, in fact inactivity is a sure way to enhance the "blues". I read an article once that said a counselor conducted his counseling sessions while taking his clients for a walk. He would not just let them sit and talk. The article said the results were amazing! As little as 20 minutes of exercise a day has been shown to brighten the mood incredibly. Don't fall into the trap of sitting in because it is too cold out. Literally just going out for a few minutes will pay great dividends!

Depression is clearly enhanced by the intake of alcohol, eating refined sugar and processed foods as well as inactivity. So the Holiday season is actually the best time to become anchored in good health practices. If you get all bundled up and take a short walk you just might meet a new neighbor and potentially a new friend or see some decorations or get some rosy cheeks! #### 6 Steps To Get Off Mailing Lists To STOP Junk Mail

Step 1: Stop the Flow

Go to the source of the flood of mailings and turn off the faucet! Remove your name from mailing lists at http://www.dmachoice.org. It can take up to 90 days for the flow to stop since many mailings are already in print or production.

Step 2: No More Credit Card Solicitations

If you've ever filled out a product warranty card, purchased a new home or vehicle, supplied your credit information to a lending institution, or simply carried a credit card, you can be sure your name and address are being circulated among an array of credit card companies hungry for your business. Don't despair -- there is help. To eliminate credit card promotional mailings, call 1-888-567-8688 (that's 888-50PT-OUT) or visit http://www.optoutprescreen.com. You will have the opportunity to choose either a five-year removal or a permanent removal. For your personal credit cards, ask the company to place you on their "in house" list that is not sold or traded to other companies.

Step 3: Put the Kibosh on Unwanted Phone Books and Catalogs and SIGN UP for our Stop Junk Mail Service!

You can choose whether you want to have a phone book and also opt out of catalogs, charity mailings and other types





of mailings for free at https://ecocycle.catalogchoice.org/dash-board. Once you register with the site, you can also opt out of specific catalogs you wish to stop receiving, and opt-out requests will be sent to those catalogs on your behalf. PLEASE NOTE: The site requires those who sign up to affiliate with an organization. Please simply choose "Eco-Cycle" as your "Green Team" when signing up if you don't see your employer, or an organization you are affiliated with, listed. This will not affect your free account in any way, and it will help us calculate our community's environmental savings.

Step 4: Contribute to Charities, Not Mailings

If you contribute once a year to a charitable organization, ask them to send you only one donation request per year. The American Institute on Philanthropy offers several tips on reducing junk mail and phone solicitations from charities at http://www.charitywatch.org/articles/seventips.html.

Step 5: Stop Junk Promo Products

If you've had it with companies sending you mailings or promo products you don't want, there is an option. First, look for any of the following phrases: return service requested, forwarding service requested, address service requested, or change service requested. If you find any of these phrases, write "refused, returned to sender" on the unopened envelope. Mail sent to "Resident," "Current Resident," or "Current Occupant" can be refused if it contains one of the above endorsements, or is sent First Class. When you receive unsolicited promo products, you can mark the envelope "Return to Sender" and put it back in the mail.

Step 6: Get Off the List of ALL Direct Marketers

There are several smaller list brokers and direct marketing firms in the U.S. besides the DMA. You'll recognize a lot of them on the list below. Just as you did with the DMA in step one, send or phone in all the variations of your name and address to the list brokers and direct marketing firms listed below. Start saving the labels of all the variations of the names and addresses, which come to your mailbox. Every variation, no matter how small (or comical), is another name on a list, which gets sold to literally thousands of businesses, so include all variations! If you prefer to go the snail mail route in removal, cut and paste actual mailing labels onto a sheet, make copies, add your signature beside each name variation on each sheet, and send them off to each of the 5 addresses below. Indicate the following: "Please remove my name and address from your mailing lists and do not rent, sell or trade my name or address."

Send an email with "remove" in the subject line and your full name, including middle initial, and address in the message. If you changed your address over the past six months, include your previous address as well.

a sanctuary for the natural rhythms of ecosystems. It turns out that these places have no voice in our political system, mostly because they have no cash. But we can speak out for them, and it turns out that the brands that make all the high-tech gear we buy can help.

The Conservation Alliance was formed 25 years ago when leaders from Patagonia, The North Face, REI and Kelty came together with the purpose of helping fund the hard-fought efforts of grassroots environmental organizations. In short, the goal of this new non-profit was to give money to the folks in the trenches so they could compete against powerful, destructive industries with deep pockets, influential lobbyists and cunning PR campaigns. It's one of the few times when even the most cynical of outdoor industry critics can nod in approval. The money we spend on all the junk we haul out into the backcountry can actually make some difference.

Over the last quarter century the Conservation Alliance has grown to over 185 member companies, including manufacturers, retailers, media, sales reps and others who make their living connected to wild places. We pay dues based on our revenue. Those dues translate into grants that are awarded to environmental groups by The Conservation Alliance. (If your grassroots environmental organization needs cash for a project or campaign, you can read about how to apply here: conservationalliance. com/grants). Since its foundation, the organization (and the companies that pay dues) have given \$13 million to hard-working conservation groups, helping to protect 42 million acres, 2,825 miles of rivers, stop the building of or remove 26 dams, designate five marine reserves and purchase nine climbing areas. This year, we hope to give out \$1.65 million in grants.

In our state, that cash has helped groups like Conservation Colorado and the Colorado Mountain Club, and recently ensured that the Western Rivers Conservancy could protect 1,169 acres and 11 river miles within the Dominguez Escalante National Conservation Area along the Gunnison River. It just empowered the Red River Gorge Climber's Coalition to acquire a 310 acre crag. It is helping the Yellowstone to Yukon Initiative oppose the building of a new dam on British Columbia's Peace River and fight to protect 1 million acres of the Sacred Headwaters, the pristine lands of the Skeena, Nass and Stikine Rivers. This is not easy work. Conservation Alliance executive director John Sterling and other members headed to Washington, D.C., last month to try to make themselves heard in the white noise of political partisan infighting. They lobbied for these places that have no voice in the venal halls of Congress and they discussed the creation of new national monuments, including Brown's Canyon here in Colorado. Thanks to the generosity, will and passion of the businesses and people who support us, there may be some hope that we can keep these places from corporate looters. But it doesn't just have to be the outdoor industry that supports us. Please, learn more about the Conservation Alliance and support our efforts. — Doug Schnitzspahn
