## LBPD WARNS PUBLIC OF COUNTERFEIT BILLS

The Long Beach Police Department would like to warn the public about the recent use of counterfeit bills at garage sales, where subjects either paid, or attempted to pay for their purchases with the use of counterfeit \$100.00 bills. Although there have only been a few reported cases, detectives are hopeful that raising awareness early will prevent others from becoming victims.

Garage sales are an easy target for criminals to pass counterfeit bills, as the general public typically is not trained to recognize security features of paper currency.

Anyone accepting hundred dollar bills should inspect the bill for unusual texture and/or print. The website <u>www.moneyfactory.com</u> explains current security features contained within U.S. currency. Portable ultraviolet light scanners and money checker pens that detect security features in currency can be purchased in office supply stores or online.

The easiest way of preventing yourself from becoming the victim of this fraud is simply to not accept hundred dollar bills. If you witness someone attempting to use a bill that appears to be counterfeit, do not attempt to detain the suspect, instead immediately call 9-1-1 so that an officer can be dispatched. A good description of the suspects and their vehicle, including license plate number and direction of travel, can greatly assist Police. It is our goal to apprehend the perpetrators of these crimes against the public, and possibly take additional counterfeit currency off the street.

## Get Ready for Fall

## The Port Rail Project

On September 16, the Port of Long Beach conducted a Public Scoping Meeting on the proposed On-Dock Rail Support Facility Project. The Port proposes to "reconfigure, expand and enhance" the existing rail facility at Pier B, southwest of Anaheim Street and the 710 Freeway. The facility currently serves as a storage and staging area for trains. The purpose of the project is to reduce the number of truck trips in and around the Port in order to improve efficiency and lower truck emissions.

The Port released a Notice of Preparation prior to the "scoping" process by which it seeks public input before developing its draft EIR (Environmental Impact Report). The Scoping Period ends September 25 and will be followed by a Public Review. The completion of all the studies is projected for late 2010. The "Preferred Project", the Project with all the proposed elements, will consist of three phases; however, the Project could be modified. Several alternatives are also being considered as part of the draft EIR, including the possibility of no Project. The Harbor Commission will have the final say.

After the 30-minute powerpoint presentation, it was the public's turn. Audience members were given the opportunity to provide their input. The consensus was that the Project is a good idea; however, many business owners voiced concerns over land use, the possibility of relocation, noise, traffic, aesthetics, and impact to their businesses, particularly with the removal of the ramp connecting 9<sup>th</sup> Street and the Shoemaker Bridge under consideration. Multi-service center representatives expressed concerns about the Port expansion impact on their facility, particularly noise and health risks, since many of the people they serve are children, citing an average of 700 homeless children served on a monthly basis. A resident of the Drake Park area expressed concerns about wildlife, and the impact of construction on endangered species in the area.

Brian Cole, a representative of the UCLA School of Public Health and Long Beach resident, expressed his concern about diesel particulates from the trains, a concern shared by Coleen Callahan, representing the American Lung Association, who stated that "the proposed project is not ideal" and asked that mitigation measures be considered, such as the inclusion of electric rail. Orthodontics for Low-Income Children

The Assistance League of Long Beach has a fantastic program to provide orthodontic treatment for children from families with limited financial resources. They will conduct their next orthodontic screening of prospective patients on October 12, 2009.

Orthodontic Screenings of prospective patients are held three times per year in February, June, and October, with more than 150 children seen at each session. Approximately fifty children with the most severe orthodontic needs are accepted from each screening into the program.

Payments are on a sliding scale and incredibly cheap for what is often very expensive dental work. Parents will be required to submit tax returns and payroll statements to help determine what payments they will be asked make.

On the average, patients pay about \$50 per month for treatment, with the range being between \$25 and \$85 per month. Most children are in braces for about 28 months.

Parent Consultations are held with each new patient and parents to review his/her individual treatment plan, dental and orthodontic responsibilities during treatment. "Adopt-a-Child's Smile" is a grant program providing scholarships to extremely low income families who qualify. Private individuals and sponsors from the community donate funds for this program.
